JOURNAL OF THE HOUSE.

Monday, August 24, 2009.

Met according to adjournment at eleven o'clock A.M., in an Informal Session, with Mr. Donato of Medford in the Chair (having been appointed by the Speaker, under authority conferred by Rule 5, to perform the duties of the Chair).

Prayer was offered by the Reverend Robert F. Quinn, C.S.P., Chaplain of the House, as follows:

Resolutions.

The following resolutions (filed with the Clerk) were referred, under Rule 85, to the committee on Rules:

Ray Conniff Bandstand.

Resolutions (filed by Representatives Bowles of Attleboro and Poirier of North Attleborough) honoring the life time achievements of Ray Conniff by celebrating the naming of the Ray Conniff Bandstand at Capron Park in Attleboro;

Admetech Foundation.

Resolutions (filed by Mr. Honan of Boston and other members of the House) recognizing the Admetech Foundation for hosting Prostate Cancer Awareness Day; and

Peter Preston.

Resolutions (filed by Mr. Ross of Wrentham) congratulating Peter Preston on his retirement after 47 years of exemplary service in the town of Wrentham;

Mr. Binienda of Worcester, for the committee on Rules, reported, in each instance, that the resolutions ought to be adopted. Under suspension of the Rules, in each instance, on motion of Mr. Kafka of Stoughton, the resolutions (reported by the committee on Bills in the Third Reading to be correctly drawn) were considered forthwith; and they were adopted.

Papers from the Senate.

A petition (accompanied by bill, Senate, No. 2132) of Bruce E. Tarr and Ann-Margaret Ferrante (with the approval of the mayor and city council) for legislation relative to the preliminary election in the city of Gloucester, was referred, in concurrence, to the committee on Election Laws. Gloucester,— preliminary election.

Reports of Committees.

By Mr. Binienda of Worcester, for the committee on Rules and the committees on Rules of the two branches, acting concurrently, that Joint Rule 12 be suspended on the petition of Pam Richardson relative to zoning of land or structures for educational uses on land owned or leased by nonprofit educational corporations. Zoning,— nonprofit educational corporations.

Under suspension of the rules, on motion of Mr. Murphy of Burlington, the report was considered forthwith. Joint Rule 12 was suspended; and the petition (accompanied by bill) was referred to the committee on the Municipalities and Regional Government. Sent to the Senate for concurrence.

By Mr. Kafka of Stoughton, for the committee on Steering, Policy and Scheduling, asking to be discharged from further consideration of the House Bill providing for the work force reduction of the city of Worcester through an early retirement incentive program for certain employees (printed as Senate, No. 2021, changed),— and recommending that the same be referred to the committee on Ways and Means. Under Rule 42, the report was considered forthwith; and it was accepted. Worcester,— retirement incentive.

By Mr. Moran of Boston, for the committee on Election Laws, on a petition, a Bill to establish the election calendar in the city of Salem (House, No. 4112) [Local Approval Received]. Read; and referred, under Rule 7A, to the committee on Steering, Policy and Scheduling. Salem,— election calendar.

Mr. Kafka of Stoughton, for said committee, reported that the matter be scheduled for consideration by the House.

Under suspension of the rules, on motion of Ms. Peisch of Wellesley, the bill was read a second time forthwith; and it was ordered to a third reading.

By Mr. Kafka of Stoughton, for the committee on Steering, Policy and Scheduling, that the House Bill relative to the Wareham Fire District (House, No. 1976) be scheduled for consideration of the House. Wareham Fire District.

Under suspension of Rule 7A, on motion of Mr. Smizik of Brookline, the bill was read a second time forthwith; and it was ordered to a third reading.

By Ms. Forry of Boston, for the committee on Community Development and Small Business, on a petition, a Bill relative to the Massachusetts Community Development Finance Corporation (House, No. 209). Read; and referred, under Rule 33, to the committee on Ways and Means. Community Development Finance Corporation.

Emergency Measures.

Dolores Tower,—
sick leave bank.

The engrossed Bill establishing a sick leave bank for Dolores Tower, an employee of the Department of Developmental Services (see House, No. 1160), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 5 to 0. Sent to the Senate for concurrence.

Crystal Pollack,—
sick leave bank.

The engrossed Bill establishing a sick leave bank for Crystal Pollack, an employee of the Department of Developmental Services (see House, No. 1161), having been certified by the Clerk to be rightly and truly prepared for final passage, was considered, the question being on adopting the emergency preamble.

A separate vote was taken, as required by the provisions of Article XLVIII (as amended by Article LXVII) of the Amendments to the Constitution; and the preamble was adopted, by a vote of 5 to 0. Sent to the Senate for concurrence.

Engrossed Bills.

The engrossed Bill authorizing the town of Nahant to issue bond anticipation notes (see House, No. 1133) (which originated in the House), having been certified by the Clerk to be rightly and truly prepared for final passage, was passed to be enacted; and it was signed by the acting Speaker and sent to the Senate.
