**Subject:** **Reemployment Eligibility Assessment (REA) and Related MOSES Training**

**Purpose:** To notify Local Workforce Investment Boards, One-Stop Career Center Operators and other local workforce investment partners of REA program training scheduled for April 2013.

**Background:** DCS Central Programs Unit, DUA and the MOSES team will conduct four training sessions in April (see Chart, below). Training sessions will cover updates to the REA program requirements, related MOSES changes and communication with DUA. Training sessions are half day in length and are scheduled in Worcester and Boston.

**NOTE: Local Office REA Experts plus one staff are required to attend.** REA Specialists and Supervisors would also benefit from this training. **Please arrive on time as training sessions will begin promptly.** Two half day sessions are offered each day. You only need to attend 1 half day session.
