## Minutes of the April 30, 2015 Open Meeting

1. Chairman Dennis Drumm opened the meeting at 9:45.
2. The Chairman confirmed that all attendees were aware of the building's emergency evacuation procedures.
3. Scott Cameron moved, seconded by Edward Englander, to accept the minutes from the March 26, 2015 open meeting. Motion to accept the minutes passed.
4. The Board discussed two emails—one from Paul Campbell and the other from Peter Furth regarding the content of Professional Land Surveyor course work that the Board had previously not approved. Since Mr. Campbell was in attendance, the Board invited him to discuss his application. The Board determined that some of the courses in question do qualify as acceptable land surveying courses. Peter Hale noted that there appeared to be an erroneous reference in Mr. Campbell's transcript and that Mr. Campbell will need to submit a corrected official transcript and additional course work.
5. The Board received and reviewed a letter from Joseph Vela, dated March 20, 2015.
6. Board Counsel informed the Board of Governor Baker's Executive Order 562 regarding regulation review that requires all agencies, including all boards of registration, to review their existing and proposed regulations to ensure that the regulations are essential to the public health, safety and welfare. The Secretariat is encouraging all agencies to hold public listening sessions to receive public comment as part of the E.O. 562 regulation review process. The Board agreed that a listening session will be scheduled at the beginning of the next board meeting.



7. Ms. LeBel informed the Board that she received an email from NCEES regarding the computer based testing for Professional Land Surveyors, which is expected to begin in October 2016. The email inquired whether the Massachusetts Board would like NCEES to administer the state jurisprudence exam. The Board determined that PCS should continue to administer the state jurisprudence exam.
8. Ms. LeBel reported that licensee 35022 submitted a request to be removed from probation. She indicated that this licensee has met the terms of the consent agreement. Edward Englander moved, seconded by Peter Hale to remove licensee 35022 from probation. Motion passed.
9. At 10:25 Mr. Englander moved, seconded by Scott Cameron, to suspend the public meeting and enter into closed session under G.L. c. 112, § 65C to discuss recommendations of the Complaint Committee. Motion passed.

Public Session resumed at 10:30.
