**Board Business:**

1. At 9:03 a.m., the meeting was called to order.
2. At 9:04 a.m., on a motion by Dr. Sanchez, seconded by Dr. Scherer, all in favor, the Board voted to enter into closed session for the purposes of investigative conferences for: PY-15-1389 (Dr. Carey recused), PY-16-001, PY-16-004, PY-15-1468, PY-16-013, PY-16-003, PY-16-010, PY-16-008, PY-16-007, PY 15-1473.
3. At 12:40 p.m., on a motion by Dr. Sanchez, seconded by Dr. Scherer, all in favor, the Board voted to exit closed session and to enter open session.
4. Dr. Carey reviewed evacuation instructions.
5. On a motion by Dr. Carey, seconded by Dr. Glover, the Board voted to approve the Board Meeting and Executive Session minutes, as amended, for the February 2016 meeting, all in favor.
6. PY-16-001: On a motion by Dr. Scherer, seconded by Dr. Sanchez, the Board voted to forward to prosecution for formal disciplinary action, all in favor.
7. PY-16-003- On a motion by Dr. Scherer, seconded by Dr. Sanchez, the Board voted to schedule for investigative conference, all in favor..
8. PY-16-004- On a motion by Dr. Scherer, seconded by Dr. Sanchez, the Board voted to reschedule investigative conference with licensee for next month, all in favor.
9. PY-16-013: On a motion by Dr. Hudgins, seconded by Dr. Sanchez, the Board voted to close with an Advisory Letter, all in favor.

10. PY-15-1468: On a motion by Dr. Scherer, seconded by Dr. Sanchez, the Board voted to forward to prosecution for formal disciplinary action, all in favor.
11. PY-16-008: On a motion by Dr. Scherer, seconded by Dr. Sanchez, the Board voted to schedule investigative conferences, all in favor.
12. PY-16-010: On a motion by Dr. Scherer, seconded by Dr. Sanchez, the Board voted to dismiss the complaint, all in favor.

14. At 12:50 pm, on a motion by Dr. Sanchez, seconded by Dr. Scherer, the Board voted to enter closed session for the purpose of a settlement conference, all in favor.
15. At 1:10 pm, on a motion by Dr. Scherer, seconded by Dr. Sanchez, the Board voted to exit closed session and re-enter open session, all in favor.
16. 2017 Board meeting schedule: Board discussed proposed dates. On a motion by Dr. Scherer, seconded by Dr. Sanchez, the Board voted to accept the proposed dates and post on the web-site, all in favor.
17. Licensee #1759: The Board reviewed correspondence from licensee's Consulting Psychologist, as per the terms of the Consent Agreement. On a motion by Dr. Glover, seconded by Dr. Scherer, the Board voted to approve a bi-weekly schedule of consultation sessions, all in favor.
18. At 1:14pm, on a motion by Dr. Glover, seconded by Dr. Hudgins, roll call vote, the Board voted to enter Executive Session, pursuant to General Laws Chapter 30A, Section 21(a)(7) to discuss medical record information and to comply with the public record law, pursuant to G. L. c. 66, § 10; G. L. c. 4, §7, ¶ 26(c), all in favor.
19. At 1:35 pm, on a motion by Dr. Glover, seconded by Dr. Hudgins, roll call vote, the Board voted to exit Executive Session and return to open meeting, all in favor.
20. Applicant Butler: Dr. Scherer recused. Unable to vote due to lack of quorum, so this matter will be on the April agenda.
21. Applicant Allen: The Board reviewed written training plan for Advanced Practicum. On a motion by Dr. Sanchez, seconded by Dr. Scherer, the Board voted to accept the training plan, all in favor.
22. Applicant Mattar, reciprocity from California: On a motion by Dr. Glover, and second by Dr. Sanchez, the Board voted to approve application for licensure and HSP, all in favor.
23. Applicant Chapman: On a motion by Dr. Scherer, seconded by Dr. Carey, the Board voted to approve training plan for advanced practicum, but the Board cannot determine if the Advanced Practicum will meet Board regulations due to forms needing to be re-submitted, all in favor.
24. Correspondence from Dr. Dorn from William James College: The Board reviewed letter from Dr. Dorn regarding internships for two current applicants and one individual who has not yet applied for licensure, regarding the fact that the internships do not meet Board regulations.

Dr. Dorn requested that the Board waive the regulations for these applicants because the error was hers. On a motion by Dr. Scherer, and second by Dr. Sanchez, the Board voted to deny Dr. Dorn's request, as all applicants are held to the same regulatory requirements, all in favor. On a motion by Dr. Scherer, seconded by Dr. Sanchez, the Board voted to affirm their non-approval of the application of Dr. Harnsberger, and to not approve the application of Dr. Williams, all in favor.

25. On a motion by Dr. Scherer, seconded by Dr. Sanchez, the Board voted to administratively approve the applications of Faás, Rauf, Martell, Markosian, Geremia, Ngo, Fitzpatrick, Van Kirk, Michelson, Mengchun, Crowe, Helfand, Hewitt, Webb, Quinn, Thorpe, all in favor.

26. At 2:13 p.m., on a motion by Dr. Sanchez, seconded by Dr. Glover, the Board adjourned the meeting.
