**NOTICE OF PUBLIC HEARING**

Pursuant to M.G.L. c. 112, §§ 61, 87LL through 87OO, and M.G.L. c. 30A, § 2, the Board of Registration of Sanitarians will hold a public hearing relative to proposed amendments to its regulations, 255 CMR §§ 2.00, 4.00 and 5.00, the rules governing registered sanitarians in the Commonwealth. By these amendments, the Board seeks to clarify a licensee's obligation to submit change of address notifications, remove outdated examination administration language and eliminate redundancies and unnecessary language in the existing regulation.

The hearing will be held at 10:00 a.m. on Wednesday, September 28, 2016, at the Division of Professional Licensure in a first floor conference room at 1000 Washington Street, Boston, MA 02118. Interested parties will be given an opportunity to present testimony, orally or in writing, at the hearing. The Board will also accept written comments regarding the proposed amendments through the end of business on October 5, 2016.
