***Re: DTC 15-2, Petition of the State 911 Department to Adjust the Enhanced 911 Surcharge***

Dear Secretary Clark:

On behalf of Comcast Phone of Massachusetts, Inc. ("Comcast Phone") and its affiliate, Comcast IP Phone II, LLC ("Comcast IP"), please accept this letter in lieu of a Motion for Limited Participant status in the above captioned proceeding.

Comcast Phone is a provider of telecommunications services in Massachusetts. Comcast IP provides Interconnected VOIP service to end user retail customers in Massachusetts. Pursuant to M.G.L. c. 6A, § 18H, Comcast IP collects and remits a surcharge for the expenses associated with providing and maintaining the Commonwealth's 911 system. On March 20, 2015, the State 911 Department filed a petition with the Massachusetts Department of Telecommunications and Cable (the "Department") to adjust the 911 surcharge from the statutory amount of \$.75 per month to \$1.25 per month through June 30, 2016 and \$1.00 commencing July 1, 2016.

As a voice provider responsible for the collection and remittance of the 911 surcharge, Comcast IP has an interest in the outcome of this proceeding, and any change in the current 911 surcharge, and the implementation of such change, will directly and specifically affect Comcast IP and its end-user customers.

Accordingly, Comcast Phone and Comcast IP seek Limited Participant status in this proceeding, in order to be included on the Service List, and where appropriate, file comments, participate in technical sessions, submit briefs and to participate in this proceeding in any other manner deemed appropriate for Limited Participants by the Hearing Officer.
