Aircraft Registration Program - Instruction Form**

Aircraft to be Registered

1. All airworthy aircraft based in Massachusetts or temporarily located in Massachusetts for sixty (60) or more cumulative days during a year must be registered with the Massachusetts Registry of Motor Vehicles (RMV) by completing and submitting a registration form and paying the applicable annual registration fee to the RMV.
2. This requirement does not apply to:
  - a. Aircraft owned by, and used exclusively in the service of any government, including the government of the United States or of any state thereof, or political subdivision thereof, which is not engaged in carrying persons or property for hire;
  - b. Aircraft registered under the laws of a foreign country;
  - c. Aircraft based in another state and located in Massachusetts less than sixty (60) cumulative days/year; or
  - d. Aircraft engaged principally in federally certificated scheduled airline operation.
3. The owner of an unairworthy aircraft shall notify the airport manager where the aircraft is based stating the date the aircraft became unairworthy, the reason for the unairworthy condition and expected date of reinstatement to an airworthy condition. Owner shall notify the airport manager and the RMV when the aircraft becomes airworthy.
4. Registration and payment of the Registration Fee is in lieu of state personal property taxes on the aircraft.
5. The deadline for receipt by the RMV of aircraft registration renewal application forms is December 31. Failure to register an aircraft as specified is a violation of 702 CMR 3.03 and may result in a late fee, as follows, in addition to the standard fee.

Instructions

1. Please print or type everything other than your signature when you complete this Registration Form.
2. Please fill out all of the applicable items on the reverse side of this Registration Form. An incomplete registration form will be returned.
3. If you are renewing your registration for this aircraft, the information from last year's registration is included on the reverse side of this Form. Please check that information for accuracy and type or print any corrections.
4. The gross weight of your aircraft in pounds determines your Registration Fee (see Schedule of Fees below).
5. Payment of the Registration Fee must be by check or money order made **payable to MassDOT. DO NOT SEND CASH!**
