#### **Informal Hearing**

Tague moved to postpone decision to next meeting and requested that Mr. Capazzoli provide the Board with a copy of his final bill and his response to original complaint which was sent to Mr. Richard Cody. Seconded by King. Motion passed 3-1.

King moved that Mr. Capazzoli has the right to file a counter-complaint within two weeks. The Board should receive the counter-complaint no later than June 7<sup>th</sup> and it should be sent separate from his response to the complaint filed against him.
