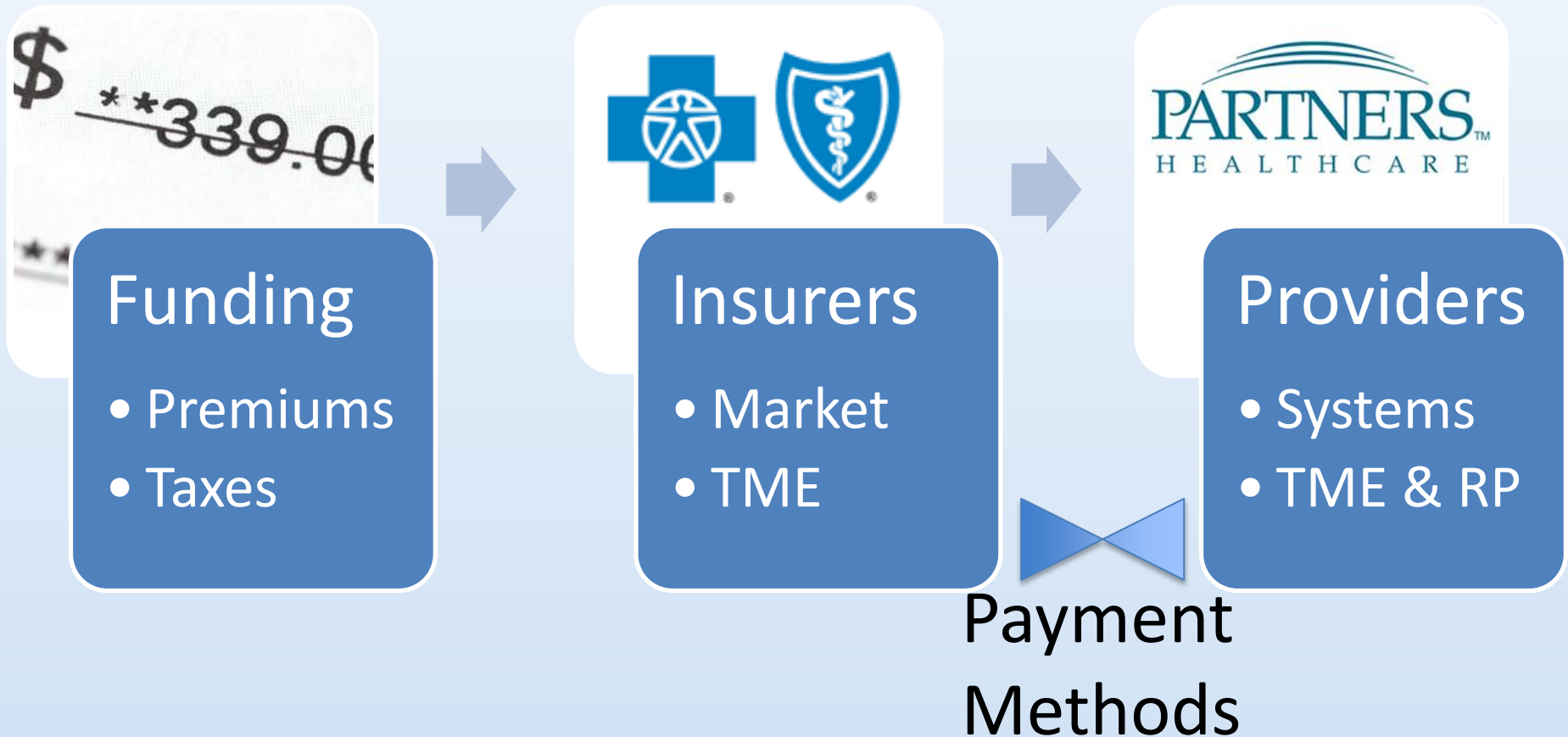

(as included in the health status adjusted TME)

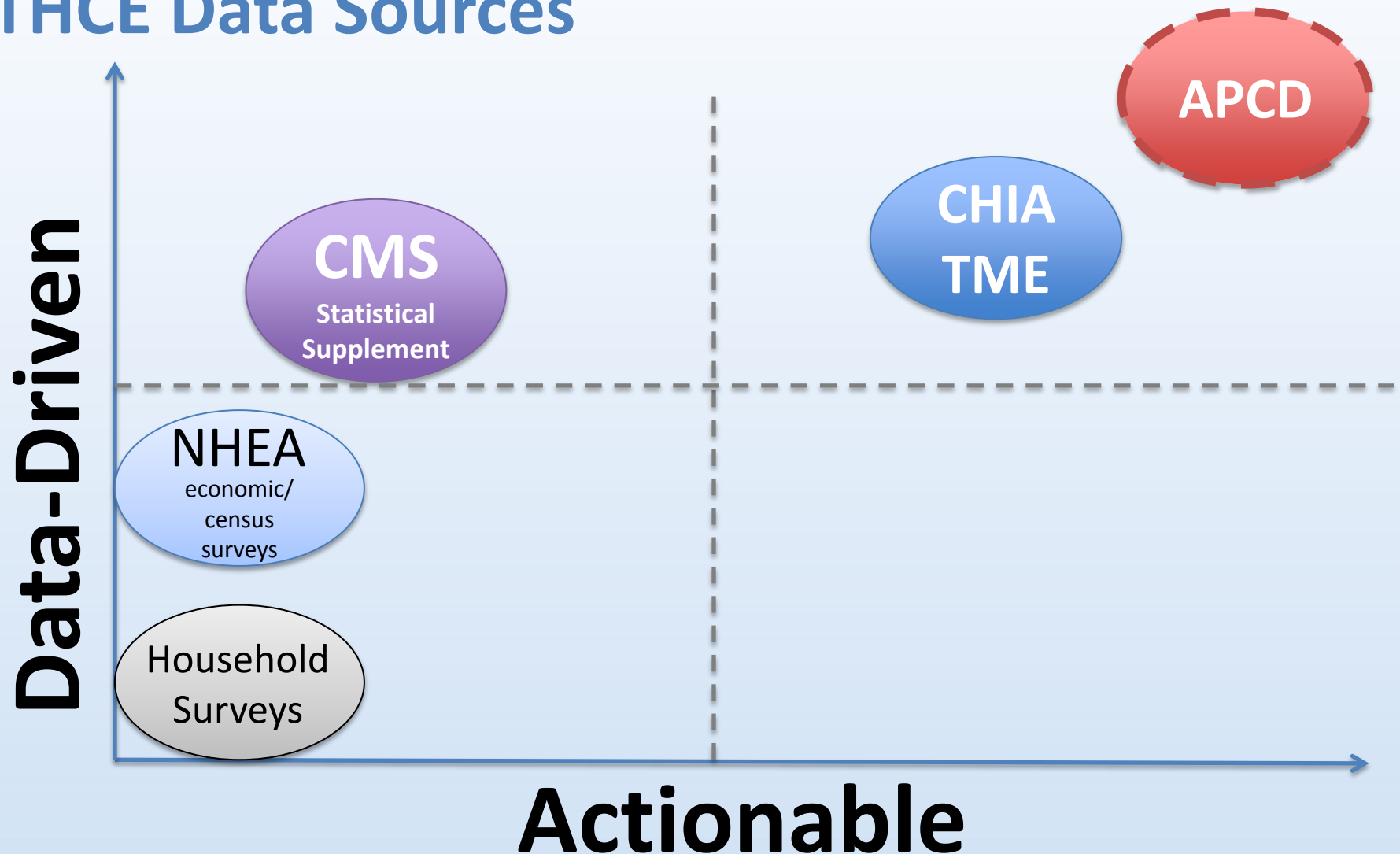
+ patient cost sharing

What is TME?

TME is defined in Chapter 288 of the Acts of 2010 as:

- (i) **allowed claims** for all categories of medical expenses,
includes member cost sharing
- (ii) **non-claims related payments to providers;**
- (iii) adjusting by health status.

TME is expressed on a per member per month basis.
