2015 Commercial Striped Bass Season

The 2015 commercial striped bass fishery will open Thursday, June 25, with a quota of 869,813 pounds. All states coastal commercial quotas were reduced by 25% beginning in 2015 under the interstate management plan. Refer to our <u>Quota Monitoring webpage</u> to see cumulative landings and remaining quota. An Advisory will be issued when the quota is projected to be taken and the fishery closed.

The open commercial fishing days are Mondays and Thursdays. On open days, a 15-fish daily limit applies to fishermen issued a Commercial Lobster or Boat Permit with a Striped Bass Endorsement; a 2-fish daily limit applies to fishermen issued a Commercial Individual or Rod & Reel Permit with a Striped Bass Endorsement. These limits apply to the permit holder regardless of the fishing location (shore or vessel), the number of permits or endorsements held, or the number of trips taken in a day. The 15-fish limit also applies to the vessel regardless of the number of permit holders onboard or trips taken in a day.

All commercially harvested striped bass must be at least 34 inches in total length and landed in the round, with the head, body and tail fully intact. Commercially harvested striped bass may not be filleted or processed in any manner except by evisceration.

During commercial trips it is unlawful for commercial fishermen to possess or land a recreational bag limit in addition to their commercial harvest or to retain any catch at the recreational minimum size of 28 inches. Commercial fishermen engaged in commercial fishing for striped bass may not fish aboard the same vessel at the same time as recreational fishermen.

When not on a commercial trip, commercial permit holders may fish for striped bass for recreational purposes if they hold a recreational fishing permit. From June 20 through the end of the commercial season, when a commercial striped bass fisherman is recreationally fishing on a closed commercial fishing day, s/he must immediately remove the entire right pectoral fin of any striped bass 34" or greater that is retained. This rule also applies to any person fishing aboard a vessel that is either named on a commercial Striped Bass Endorsement or carrying the holder of a commercial Striped Bass Endorsement. This rule is **new in 2015**; see our prior <u>Advisory</u> for more details.

Commercially harvested striped bass can be sold only to dealers authorized to purchase striped bass from harvesters. Our website provides a list of <u>striped bass primary buyers</u>. Click on "STB" to sort the list by municipality. All striped bass harvested under the authority of a commercial permit, whether sold or kept for personal use, must be reported to the Division of Marine Fisheries on monthly trip-level <u>reporting</u> forms. Failure to submit these reports for all months of the year in a timely manner may result in the non-renewal of commercial permits and endorsement in 2016.
