NMFS Schedules Massachusetts Public Meetings Concerning Entanglements and Right Whale Conservation

On August 20th and 21st, there will be two federal meetings in Massachusetts hosted by the National Marine Fisheries Service to receive comments on possible alternatives to reduce risk of entanglement and serious injury & mortality attributable to the American lobster fishery for northern right whales. NMFS is holding a total of eight scoping meetings from Maine to Rhode Island in anticipation of preparing a Draft Environmental Impact Statement (DEIS) for modifications to the Atlantic Large Whale Take Reduction Plan. The purpose of these meetings is to collect information from interested parties to help NMFS determine the scope and significant issues that should be addressed in-depth in the analyses included in the DEIS.

The Large Whale Take Reduction Team produced in April 2019 a set of near-consensus framework recommendations. Reductions in vertical buoy lines and gear modifications are the preferred strategies that the Team identified to minimize harm to right whales. DMF has been in regular communication with NMFS staff providing updated data analyses and advice. DMF has strongly urged NMFS make every effort to strive for a single set of regulations within each LCMA across the states and federal jurisdictions. DMF staff will be participating in these meetings along with NMFS to provide the agency's input and data analyses compiled from its extensive data collection program.

At the scoping meetings, NMFS will provide a brief presentation laying out the regulatory context, providing information on the status of right whales, and discussing the Atlantic Large Whale Take Reduction Plan and the Team's recent deliberations and recommendations. Public comment will be taken after the presentations. Written comments may also be submitted at the meetings. NMFS is hoping these meetings result in an open exchange of information between industry, conservation advocates, and regulators.

Fishermen are welcome to attend any or all meetings.

Written comments are also welcomed.
