 - a. Call to Order: John Guswa called the meeting to order at approximately 12:52 p.m. The Board members in attendance were Robert Rein, David Austin, Deb Listernick, Kirk Franklin, Farooq Siddique, Ben Ericson, and Kathleen Campbell. Gail Batchelder arrived at 12:53 p.m. James Smith was absent. Staff members present were Beverly Coles-Roby, Lori Williamson, and Lynn Read. Also present were Wendy Rundle, Executive Director of the Licensed Site Professional Association ("LSPA"); Wes Stimpson of WES Associates; Dominic Galluzzo; and Sarah McKnight.
 - b. **Announcements**: Ms. Coles-Roby announced that Lynn Read was leaving the agency effective October 31, 2014.
 - c. **Previous Minutes**: The draft minutes of the meeting held on September 11, 2014, were approved with a minor correction. John Guswa and Robert Rein abstained from voting to approve the minutes.

6. Old Business:

Kathy Campbell reported that she had not received comments regarding the Continuing Education Regulations matrix. Ben Ericson indicated that it might be helpful to meet with members of the Bureau of Waste Site Cleanup regarding the proposed regulation changes. The Committee agreed that it would invite Susan Fessenden, MassDEP Bureau of Waste Site Cleanup, Clean Energy Outreach Training Coordinator, to meet before its meeting on November 20, 2014. Mr. Ericson added that the Committee should consider creating a more formal process for approving MassDEP courses when the Board is not meeting that would allow the Committee's chairperson to approve courses. Mr. Guswa requested that the Committee review Ms. Fessenden's suggested revisions to the regulations. Mr. Austin wondered if there was any low hanging fruit, i.e., regulation changes, which the Committee could propose now. Mr. Ericson commented that regulation amendments require so much administrative effort in Massachusetts. Ms. Coles-Roby asserted that she envisioned completing a regulations package from the LSP Board by the end of 2015, for promulgation in the spring of 2016.

Mr. Ericson thought it would be helpful to know what other jurisdictions require in the way of Continuing Education for its licensees. Ms. Batchelder told the Committee that the Alternative Learning Format Committee ("ALF") examined this issue. She went on to say that most states have a random auditing procedure, and very few jurisdictions have an approval process. Ms. Batchelder said she would forward the matrix. Ms. Rundle stated that the ALF examined Continuing Education policies in Connecticut, New Jersey and New York. Mr. Siddique suggested that Ms. Williamson research the things suggested in Ms. Campbell's matrix. Ms. Campbell moved to place the matrix on the agenda for the Committee's next meeting.

The ALF Committee submitted its written report and requested that Committee members forward their comments to Ms. Coles-Roby.
