### **Proceedings**

# I. Welcome, Roll Call, and Approval of 10/20/21 Meeting Minutes – 10:00am

- a. Representative Garlick welcomed Commission members to the second meeting of the Commission on the Status of Persons with Disabilities. Rep. Garlick explained the accessibility: ASL interpreters were on the Zoom call, CART services were available, and the meeting was being livestreamed on <a href="mailto:malegislature.gov">malegislature.gov</a> for public viewing.
- b. Roll call was called with 13 members present (see table on page 1).
- c. Representative Muratore motioned to accept the meeting minutes; Charlie Carr seconded the motion. The Commission unanimously approved the minutes among those present.

d. Representative Garlick provided an overview of the proposed ARPA spending bill, H.4219, not yet engrossed by House of Representatives (Note: Legislation has since been signed into law as Chapter 102 of the Acts of 2021.

#### II. Review of Values Statements – 10:11am

- a. Chair Garlick presented the final version of the Values Statements, as discussed in previous meetings.
- b. Commissioners echoed the need for examining how to improve and evaluate existing programs and the need to provide funding for individuals with disabilities.
- c. Chair Garlick added that there was funding in the budget and ARPA for people with disabilities and the Commission can help see the whole picture.
- d. The Commission agreed that it will consider ways to share materials and information on the Commission in different languages in order to improve access.

## III. Review of Annual Report – 10:27am

- a. Chair Garlick discussed the draft annual report that had been shared publicly beforehand. Chair Garlick will file the report with the appropriate bodies on behalf of the commission members, as required by the enabling statute. The submission of annual report allows the commission to move forward with goals.
