# GWSA Implementation Advisory Committee (IAC) November 19, 2020, 9:30 AM – 11:00 AM Virtual Meeting on Windstream

# Meeting Minutes – APPROVED 4/12/21

#### Welcome

Undersecretary David Ismay called the meeting to order at 9:33am. He welcomed the IAC members/delegates and non-IAC viewers and laid out guidelines for participation in the virtual meeting.

## **Meeting Minutes**

The minutes from the October 22<sup>nd</sup> meeting were discussed. Kurt Roth raised a clarification that the IAC vote to adopt the introduction and guiding principles of the IAC's policy priority recommendations document passed but not unanimously. With that correction, the minutes were then unanimously approved.

### **State Agency Updates**

Dan Gatti of EEA provided two updates:

- The most recent ZEV Commission meeting took place recently. With the Commission's input EEA/DOER is working on the first medium- and heavy-duty incentive program, which is nearly ready for roll-out. Final policy proposal will likely be ready in early 2021.
- EEA/DOER is also working on a mechanism to have dealerships provide MOR-EV rebates at point-of-sale, with the hope of having that offering in 2021.

MassCEC provided several updates. Peter McPhee provided an update on two new programs:

- MassCEC is working on an EmpowerMASS program geared toward directing clean energy deployment to underserved and environmental justice community.
- MassCEC is also working on a new Pathway to Decarbonization program, which works directly
  with homeowners to develop scalable implementation pathways for how to renovate residences
  to high-performance, all-electric benchmarks.

Ariel Horowitz of MassCEC provided two additional updates:

- The <u>Notice of Intent</u> is now available for MassCEC's next round of clean transportation funding (ACTNow 2). They expect to release the full RFP in early 2021.
- The rolling out of the Clean Energy & Resiliency (CLEAR) Technical Support grants for clean, resilient, distributed energy projects is underway.

## Release Plan for 2050 Roadmap and the 2030 CECP

David Ismay provided an update on the release plan for the Clean Energy and Climate Plan for 2030 and the 2050 Decarbonization Roadmap. The 2050 Roadmap and the interim 2030 CECP were noted as on track for a December publication, followed by a public comment period on the interim 2030 CECP through most of January and February, and finalization of the plan in March 2021. David noted that many portions of the reports would be translated and video/webinar materials would be posted online

in several languages. Eugenia Gibbons asked how much public feedback will be used to inform the final 2030 CECP. David confirmed that all submitted feedback would be reviewed and considered. David also confirmed that the 2050 Roadmap will be released with technical support documentation, including several sector-specific technical reports. EEA is also working to host some of the energy pathways data online. Eugenia offered her support for engagement efforts around the interim 2030 CECP, which David noted was appreciated.

#### **IAC Work-Plan for 2021**

The IAC members discussed desired areas for their engagement in 2021. Steve Long suggested three priorities: 1) Dialogue on funding gaps; 2) Additional analysis needed on carbon storage and sequestration; and 3) More dialogue and exploration of offsets.

Caitlin Peale-Sloan suggested that the IAC should keep a close eye on DPU 20-80 docket regarding the future of Gas in the Commonwealth.

Mackay Miller suggested three priorities: 1) Helping Massachusetts to craft asks and engagement with a new federal administration; 2) Crafting an approach for regional collaboration; and 3) Robust engagement with real estate and building trades.

Sarah Simon suggested EEA and the IAC collaborate more with other Massachusetts state agencies.

Jeremy McDiarmid suggested planning for infrastructure development and a continued emphasis on equitable access and justice impacts across the board. Sarah Simon added EV infrastructure to this suggestion.

Eugenia Gibbons suggested a focus on implementation and action, and noted that the Climate Justice Work Group (CJWG) would continue to regularly review implementation in regards to the recommendations that the CJWG and IAC have made over the past year.

Kurt Roth suggested collaboration with other entities outside of Massachusetts, including leveraging federal partnerships, NYSERDA, and the California Energy Commission, particularly with respect to technology development and demonstration to address known implementation gaps, e.g., cost-effective deep-energy retrofits.

### **Other IAC Business**

Steve Long revisited the motion to have a non-state-staff Chair or Co-Chair for the IAC.

#### **Public Comment**

Members of the public attending the meeting asked questions about the public comment portal for submitting comments on the interim 2030 CECP, the 2030 emissions limit, coordination with the Legislature on the climate legislation and the 2030 CECP, and how municipalities can get coordinated and assist with the 2030 CECP implementation, including strategies to decarbonize existing and new buildings in Massachusetts. Eugenia Gibbons put in a plug for public engagement in the EEAC process.

The meeting was adjourned at 11:01am.
