Dear Ipswich Select Board:

In accordance with Chapter 130, Section 74A of the Massachusetts General Laws, the Division of Marine Fisheries has closed N5 "Ipswich River", N6 "Cranes Beach", and a portion of N4 "Plum Island Sound" in the Town of Ipswich this afternoon at approximately 2:30 p.m. due to wastewater discharge into the Ipswich River on January 10, 2024, from approximately 7:40 a.m. to approximately 3:00 p.m. caused by heavy rains and rising temperatures melting snow.

Therefore, the below defined **CONDITIONALLY APPROVED** and **APPROVED** classification areas are closed to the harvest of shellfish for direct human consumption. Digging, harvesting or collecting and/or attempting to dig, harvest or collect shellfish and the possession of shellfish from the below defined area is prohibited.

Portion of N4 Plum Island Sound

"The waters, flats and tributaries of Plum Island Sound in the Town of Ipswich, south of a line drawn from the foot of Quay Road near the Ipswich Bay Yacht Club (42.708488, -70.796875) northwest to the westernmost point of Ipswich Bluff (42.710355, -70.789126)"

STATUS: CLOSED TO SHELLFISHING

N5 Ipswich River

"The waters, flats and tributaries of the Ipswich River in the Town of Ipswich."

CLASSIFICATION: APPROVED
STATUS: CLOSED TO SHELLFISHING

N6 Cranest Beach

“The waters and flats of Cranes Beach in the Town of Ipswich.”

This shellfish growing area shall remain in the “Closed to Shellfishing” status until Thursday February 1, 2024, at a minimum and the status will not automatically revert to “Open to Shellfishing” until examined by the Division and notification is made that the area has been placed in the open status.
