**SUBJECT:** MassHealth: MassHealth Section 1115 Demonstration Post-Approval Forum

**AGENCY:** Massachusetts Executive Office of Health and Human Services

The Massachusetts Executive Office of Health and Human Services (EOHHS) will hold a post-approval forum to review highlights of the 2022-2027 demonstration. This presentation will be similar to one that was held in October 2022 and will give the public an opportunity to provide meaningful comments on the approved demonstration.

The MassHealth Section 1115 Demonstration provides federal authority for Massachusetts to expand eligibility to individuals who are not otherwise Medicaid or CHIP eligible, offer services that are not typically covered by Medicaid, and use innovative service delivery systems that improve care, increase efficiency, and reduce costs.
