## SHELLFISH PURIFICATION PLANT CONTAMINATED HARVEST SCHEDULE SET

The Massachusetts Division of Marine Fisheries has set the Shellfish Purification Plant soft shell clam contaminated harvest for the weeks of November 20, December 18, December 25, 2006 and January 1, 2007.

There will be no digging on Thanksgiving, Thursday November 23, 2006. Prior to the Christmas Holiday there will be no digging on Thursday December 21 and 22, 2006. Finally there will be no digging on Christmas, Monday December 26, 2006 and New Years Day, Monday January 1, 2007.
