This letter is submitted on behalf of Steward Carney Hospital, Inc. (the “Hospital”), which operates Steward Satellite Emergency Facility – Quincy, located at 114 Whitwell Street, Quincy, MA 02169 (the “Satellite Emergency Facility”). Pursuant to 105 CMR 130.122, the Hospital hereby informs the Department of Public Health (“Department”) that on or about Monday, August 3, 2020, it intends to submit a formal ninety-day (90) notice of the proposed discontinuation of the Satellite Emergency Facility.

Please note that in compliance with the Department’s regulations, the Hospital through separate correspondence is sending notice today to the Hospital’s patient and family council, each staff member of the Hospital, and every labor organization that represents the Hospital’s workforce during the period of the essential services closure process. Notice is being sent today to the members of the General Court who represent the Cities of Boston and Quincy, as well as appropriate local elected officials.
