Public Hearing Notice Right Whale Protections and Whelk Gauge Size

Under the provisions of M.G.L. c. 30A and pursuant to the authority found at M.G.L. c. 130 §§ 2, 17(10), 17A, 80 and 104, the Division of Marine Fisheries (DMF) is proposing draft regulatory amendments to 322 CMR §§6.00 and 12.00 to protect right whales and increase the minimum whelk gauge size.

1. Right Whale Protections (322 CMR 12.04 and 12.05).

- a. <u>Small Vessel Speed Limit</u>: DMF is proposing to implement a 10 knot speed limit for vessels smaller than 65' within those waters of Cape Cod Bay south of 42°08' N latitude and west of 70°10' W longitude during the period of March 1 April 30. This is being proposed to prevent potential injury and mortality to right whales caused by ship strikes. A complementary federal rule exists that regulates vessels 65' and greater in this time and area.
- b. <u>Process to Adjust Speed Limit and Large Whale Seasonal Trap Gear Closure</u>: DMF is proposing to establish a declaratory process whereby the Director may adjust the duration of the above proposed speed limit rule or extend the Large Whale Season Trap Gear Closure in response to the presence of right whales in Massachusetts' waters.
- 2. Whelk Gauge Increase (322 CMR 6.21). DMF is proposing to increase the whelk gauge width by 1/8" on a biennial basis beginning in 2019 and concluding in 2029. This is being proposed to protect spawning stock biomass. The proposed gauge schedule and its anticipated protection of female spawning stock are described in the table below.
