## **Emergency PSP Closure for Whelk Harvesting**

Effective Date: Immediately

Effective immediately, the waters referred to as the Temporary Paralytic Shellfish Poisoning Closed Areas are now also closed to gastropod harvesting. Gastropods include, among other species, whelks, conchs, and snails. These areas have been closed to bivalves and whole/roe on scallop harvesting since 2005. The closure is now expanded to also include gastropods. A map of the area and coordinates is available on the next page.

Frequently Asked Questions				
Why now?	It appears that the whelk fishery has recently expanded into Federal waters. The area in the			
	chart has been closed to bivalve harvesting since 2005. However, the closure did not			
	include gastropods, because there has never been a Federal fishery for them. Now that			
	there is an expanding fishery, we have been directed by the US Food and Drug (FDA)			
	Administration to close these waters.			
How long	It's hard to say. The FDA is actively looking into this issue and how long the closure is			
will this be	kept in place depends largely on the results. NMFS defers to the FDA in matters of public			
effective?	health, so we would need a recommendation from the FDA to lift the closure.			
Can I	Yes, but the regulations can get complicated. If you have a Federal lobster permit, any pots			
harvest	or traps used to fish for gastropods are considered lobster traps, and must comply with all			
gastropods	Federal lobster regulations. If you do not have a Federal permit, you need to be in			
in other	compliance with the Atlantic Large Whale Take Reduction Plan, which regulates lines that
