**VENDORS MUST REGISTER IN COMMBUYS BY JULY 31, 2015** 

Date: July 15, 2015

As of July 1, 2014, the Department of Housing and Community Development (DHCD) began the use of <a href="COMMBUYS">COMMBUYS</a> for all purchasing and procurement activities. The COMMBUYS market center is Massachusetts' online procurement system, linking Commonwealth public purchasers in search of products and services with sellers who are able to provide them. All procurement activity, including bid posting, bid submission, purchase orders, and vendor email notification, is managed through COMMBUYS.

The Operational Services Division (OSD) is working closely with the State Comptroller to rollout Phase II of COMMBUYS which will interface with MMARS for payments. Phase II of COMMBUYS will go live between mid-August and mid-September. This will require that all local housing authorities (LHAs), contractors and vendors register in COMMBUYS, no later than July 31, 2015.

If local housing authorities and any other vendors do not register in COMMBUYS, DHCD will not be able to send capital funds or operating subsidy. Attached is a PDF for vendor registration.

Since your Authority or business has an active contract with DHCD it is essential that you register in COMMBUYS to continue receiving notification of bidding opportunities and to access purchase order details going forward.

COMMBUYS registration is free and takes a few minutes to complete. Simply go to <a href="www.COMMBUYS.com">www.COMMBUYS.com</a>, select the first link titled **REGISTER**, and complete the requested information. Please note that you should register the correct legal entity name for your Authority or business.

Failure to register could jeopardize future payment to your Authority or business. Please register by July 31, 2015.
