## Commonwealth of Massachusetts.

AUDITOR'S DEPARTMENT, BOSTON, January 14, 1874.

*To the Honorable Senate and House of Representatives.*

I have the honor to present herewith the Twenty-Fifth Annual Report of this Department, for the year ended December 31, 1873.

The laws pertaining to the matter and form of the Auditor's Report, which seem to be essential to a full understanding of the same, are as follows:—

“The annual report of the Auditor shall contain a summary statement of the receipts into and payments from the treasury of the Commonwealth for the preceding year; also a detailed and particular statement of the receipts and expenditures belonging to each year; said detailed statement of expenditures to include, first, the expense incurred during the year for the support of all permanent departments, services and institutions; and, second, all special and exceptional charges, incurred for objects ordered within the year, the account being constructed in such manner as to show the expenditures actually incurred within the year, as far as can be ascertained, whether the same have been paid during the year, or whether the whole or part thereof remain unpaid at the close of the year.

“The Auditor's Report in each year shall show the aggregate amount of funded debt at the beginning and end of the year respectively, the balance of increase or decrease, and a statement of the cause of such balance; and in like manner shall show the aggregate amount of all temporary loans at the beginning and end of the year, the balance of increase or decrease, and a statement of the cause of such balance. The report shall likewise state whether the ordinary expenses of the year have exceeded the income, or the contrary, and show the amount of balance.

"It shall be the duty of the Auditor to include in his report the items of all accounts of expenditures, so far as they may be useful or interesting to the people of the Commonwealth; and in particular, so far as may be practicable, the various heads of expenditure shall be separated, so as to show the different officers or boards under whose directions the several portions of the expenditure have been incurred; all salaries and other general charges shall likewise be separated so as to show the different classes of officers who receive the several portions of the expenditure; and no expenditure exceeding five hundred dollars shall be included under any indefinite head if it be composed of separate items.

"The Auditor's Report shall annually contain a particular statement of the transactions of the funds belonging to, or held in trust by, the Commonwealth, including new investments of any portion of said funds, which may have been made during the preceding year, and also of the manner in which the moiety of the income of the school fund applicable to educational purposes has been disbursed.

"The Auditor shall also include in his report an estimate for the current year of the ordinary revenue of the Commonwealth, and of such other means as he may be able to point out for the defraying of expenditures."

The Summary Statement which follows shows the entire receipts into and payments from the treasury during the year. For the expenditures properly belonging to the year 1873, so far as the same can now be ascertained, reference must be had to statement No. IX.

On the first day of January, 1875, the Harbor Improvement Loan, amounting to \$230,000, will mature. This loan was authorized by chapter 446 of the Acts of the year 1869, for the purchase of certain riparian rights and flats in South Boston; and it was provided, in effect, that the loan should be repaid from the proceeds of sales of any of the lands so purchased and of any lands contained in section one of the South Boston flats. A contract for the sale of a portion of said flats, amounting to more than the sum of said loan, was afterwards made by the Commonwealth to the Boston and Albany Railroad Company, which said company was to pay for on the first day of October, 1872. Another contract has since

been made, by which the time for payment has been extended to October 1, 1876. Another sale was made to the Boston, Hartford and Erie Railroad Company from which no money has been realized; so that there is no money in the treasury, and none is likely to be received before the maturity of the loan, from which said loan can be paid. I have therefore added the amount to the estimates for the current year; as, unless the legislature shall provide the means in some other mode it must be raised by taxation.

The estimate for Military purposes is largely increased; mostly for uniforms for the Militia, which the adjutant-general places at the large sum of \$190,000.

The net receipts from corporation taxes have fallen off to about \$309,000, mostly by reason of the failure of Insurance Companies occasioned by the great fire in Boston; while the receipts from the Annual Insurance tax have been largely increased; attributable mainly to the same calamity, in that it has caused the cancellation of a large number of policies and required an extraordinary amount of re-insurance; the tax being based upon premium receipts.

The net receipts from the tax upon National Bank stocks will be about \$185,000.

The receipts from the Savings Bank tax have continued to increase, reaching the large sum of \$1,454,719.46.

A state tax of from \$1,500,000 to \$2,000,000, depending upon the amount of additional or extraordinary appropriations to be made at this session, will probably be required to meet the authorized expenditures and at the same time leave a sufficient amount of cash on hand at the close of the year to answer the calls upon the treasury till the ordinary revenue of the succeeding year shall begin to be realized.

#### NEW HOSPITAL AT WORCESTER.

The payments thus far made from the treasury on account of this Hospital amount to \$169,954.24, all of which has been paid from the revenue. The receipts to the hospital fund from sales of the old hospital lands have amounted only to the sum of \$59,896.07, of which the sum of \$51,513.26 has been received in cash, the balance being represented by mortgage securities. This cash has been transferred to the reve-

nue in part payment for advances; thus leaving the payments \$118,440.98 in excess of the receipts. Still further advancements from the revenue will probably be called for, as the sale of land is not likely to keep pace with the expenditures.

## NEW HOSPITAL AT DANVERS.

A site for the new Hospital in Essex County has been selected in the town of Danvers. Only the small sum of \$409.65 has yet been drawn from the treasury. The loan authorized for this expenditure has not been negotiated.

## NEW STATE PRISON.

A site for the new state prison has been secured in the town of Concord. Only a small amount, viz., \$916.75, had been paid on this account at the close of the year. The law authorizing the erection of the new prison directs the treasurer "to borrow such sums, not exceeding in the aggregate \$1,000,000, as may be necessary, from any of the sinking funds of the Commonwealth having uninvested moneys in their possession," to meet any expenses incurred under the provisions of the Act. (See Acts of 1873, chap. 155.)

## BOSTON HARBOR IMPROVEMENTS.

A loan of \$400,000 has been authorized for the harbor improvements, and the work is under contract. No part of the loan has been issued. The payments, which have been made from the revenue in anticipation of the issue of the loan, amount to \$16,864.69.

## TROY AND GREENFIELD RAILROAD AND HOOSAC TUNNEL.

Sterling scrip to the amount of \$798,600, and federal bonds to the amount of \$400,000 have been negotiated during the year, leaving £35,000—equal to \$169,400 of the authorized issue—still unsold.
