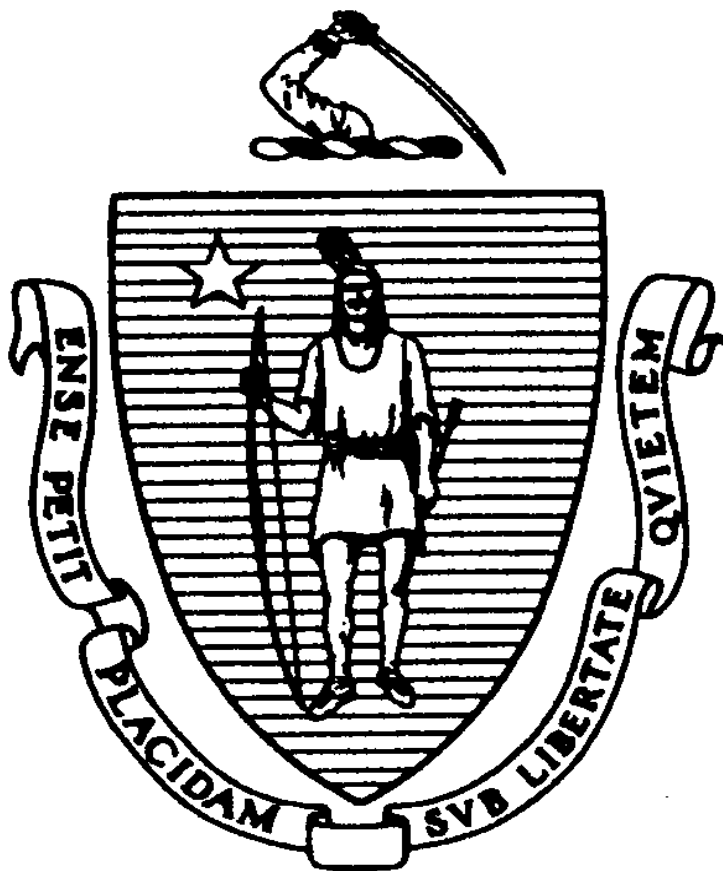

Executive Summary

The total number of offenders sentenced to Massachusetts county facilities (jails and houses of correction) during 1998 was 18,748. The breakdown by gender was 17,781 males (95% of total population) and 967 females (5% of total population). The largest racial/ethnic group represented was Caucasian (59%), followed by African American (21%) and Hispanic (18%). The average age of inmates incarcerated during 1998 was 31 years (for both males and females), ranging from 16 to 79 years of age. The average sentence length was six months. The average educational level was 11th grade.

Highlights

- In 1998, there were 18,748 commitments to county facilities. This represents a decrease of six percent from the 19,842 commitments in 1997, the first decrease over the last ten years.
- The total number of female commitments decreased from 1997 to 1998 by 15, despite the percent of female offenders remaining five percent of the total new county commitments since 1995.
- Despite the recent decrease among females in County facilities, there has been a 94% increase over the ten year period 1989 to 1998.
- Bristol County had the largest decrease in commitments (25%) from 2,655 in 1997 to 1,979 in 1998.
- Twenty-four percent of county commitments were committed for offenses against the person, twenty-one percent for property offenses, nineteen percent for drug offenses, thirteen percent for motor vehicle offenses, twelve percent for 'other' offenses, ten percent for operating under the influence of alcohol (OUI) and two percent for sex offenses.
- The most common offenses for which offenders were committed were assault/assault and battery (fifteen percent), motor vehicle violations (twelve percent), and O.U.I. (ten percent).
- Three percent were committed in lieu of a fine. There was a significant reduction (40%) in fines issued compared to the previous year (1997).
- Of the five general offense types, sex offenders are the only group to have slightly increased from the previous year (1997 to 1998) by four percent.

Introduction

This report provides a statistical description of offenders committed to Massachusetts county facilities (jails and houses of correction) during 1998. Offenders are described in terms of commitment institution, month of commitment, committing court, offense, sentence length, sentence type (weekend and jail sentences), sex, age, race, marital status, education, place of birth, and residence. Trends in court commitments to the county correctional system over the past decade are also presented.

All new court commitments and those individuals who began serving a new sentence during the year are included in this report. If an individual was committed more than once during 1998, each court commitment for that individual is counted separately.

The statistical tables were derived from information submitted by each county facility to the Research and Planning Division of the Massachusetts Department of Correction (DOC), and were produced on the DOC's VAX Computer System. A glossary of terms is provided in the back of this report to reference definitions of some terms used.

There are fourteen counties in Massachusetts. All counties except for Nantucket county have at least one county correctional facility administered by the county sheriff.

These facilities usually contain a jail for pre-trial detainees, and a house of correction for sentenced inmates. Suffolk county has a separate facility for its jail (Nashua Street) and its house of correction (South Bay). Middlesex county has two facilities, a combined jail and house of correction in Billerica and a jail in Cambridge.

Four counties have specialized facilities for sentenced offenders: Essex county has the Correctional Alternative Center (CAC) in Lawrence; Hampden county has the Western Massachusetts Correctional Alcohol Center (WMCAC) facility in Springfield; Bristol county has the David R. Nelson Correctional Addiction Center (DRNCAC) in New Bedford; and Norfolk county has the Braintree Alternative Center (BAC) in Braintree. Individuals are not committed directly to these four facilities, but can be transferred to them from a house of correction or state correctional facility.

This report has been organized into three sections. The first section describes the demographic characteristics of 1998 commitments. The second section depicts information about criminal offenses for the inmate population. The third section addresses data regarding sentencing, such as court from which committed, type of sentence, and sentence length. Please note that due to rounding, percentages may not add to 100%.

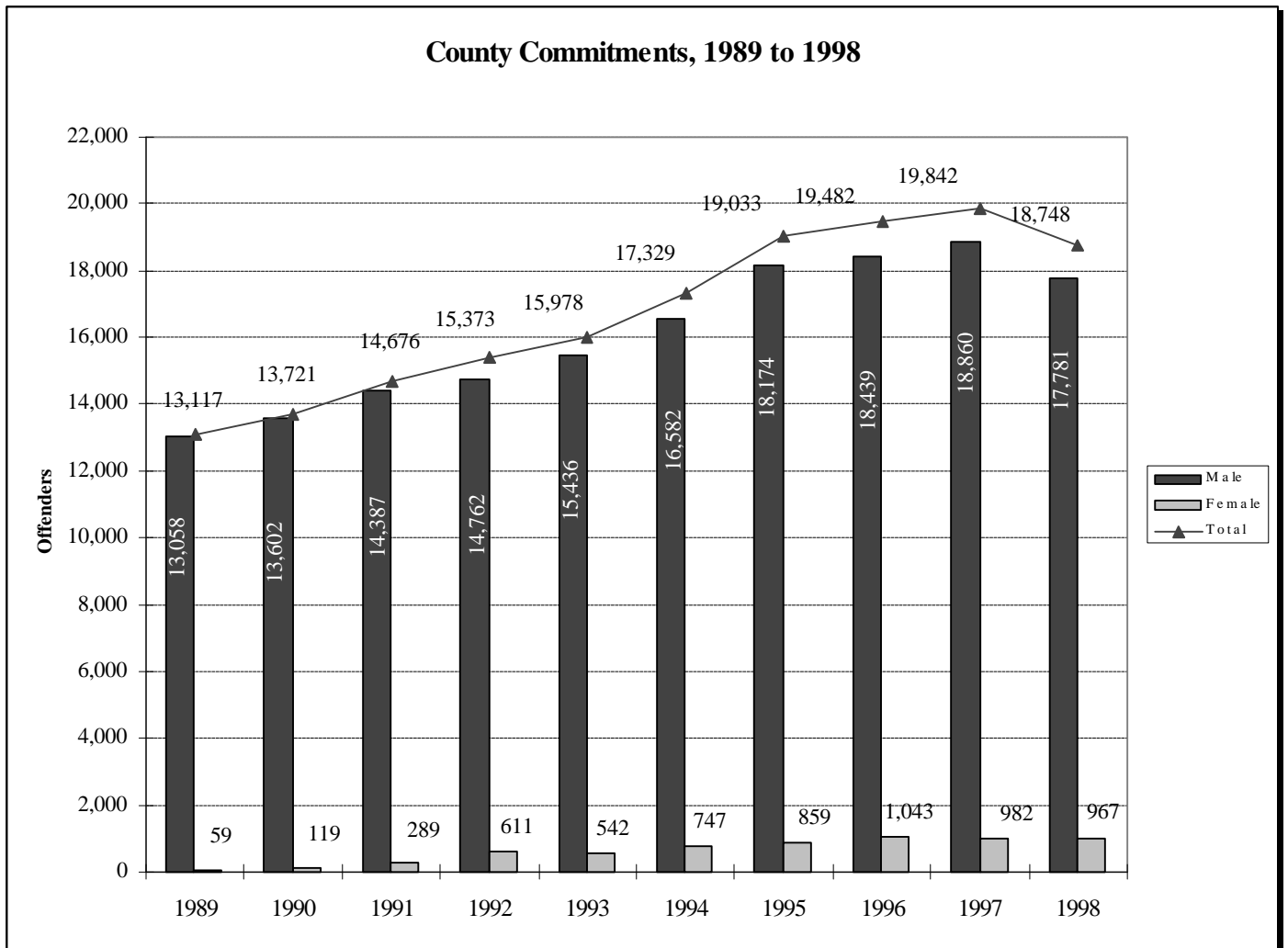

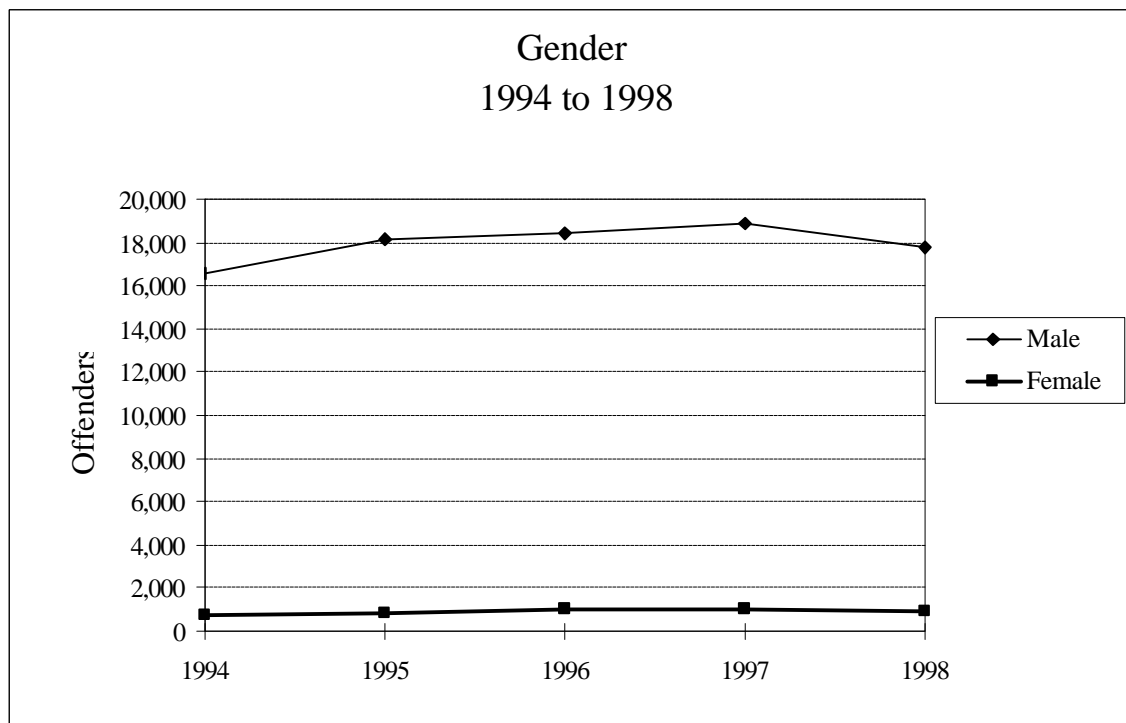

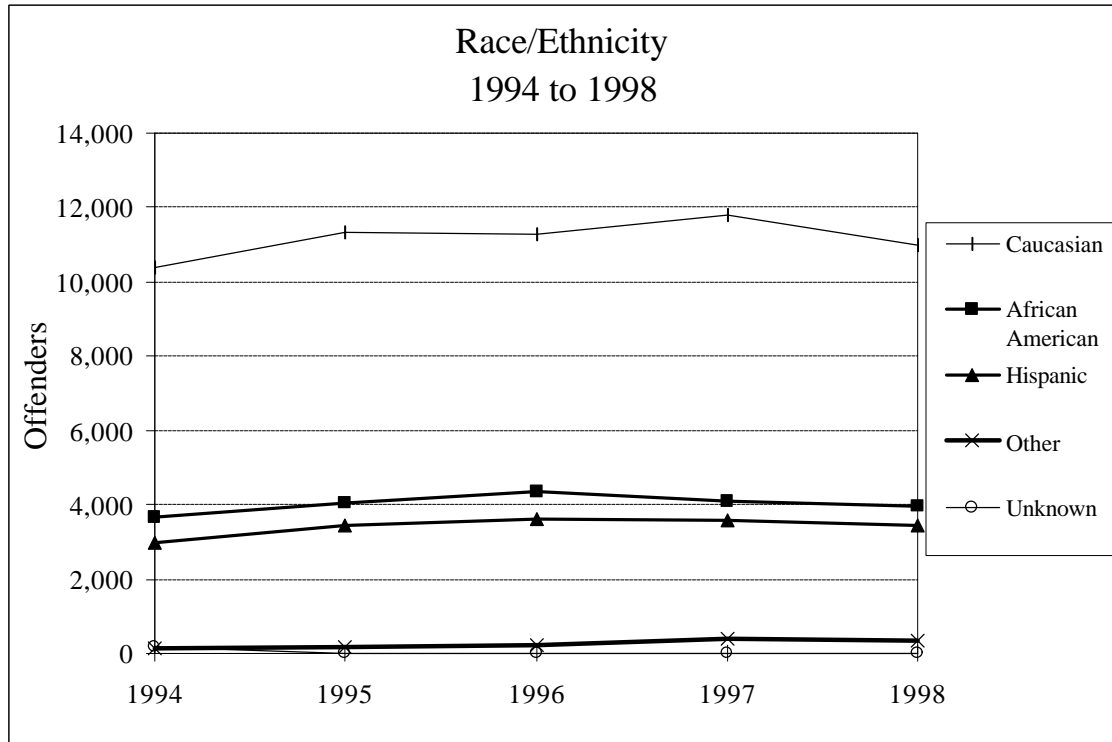

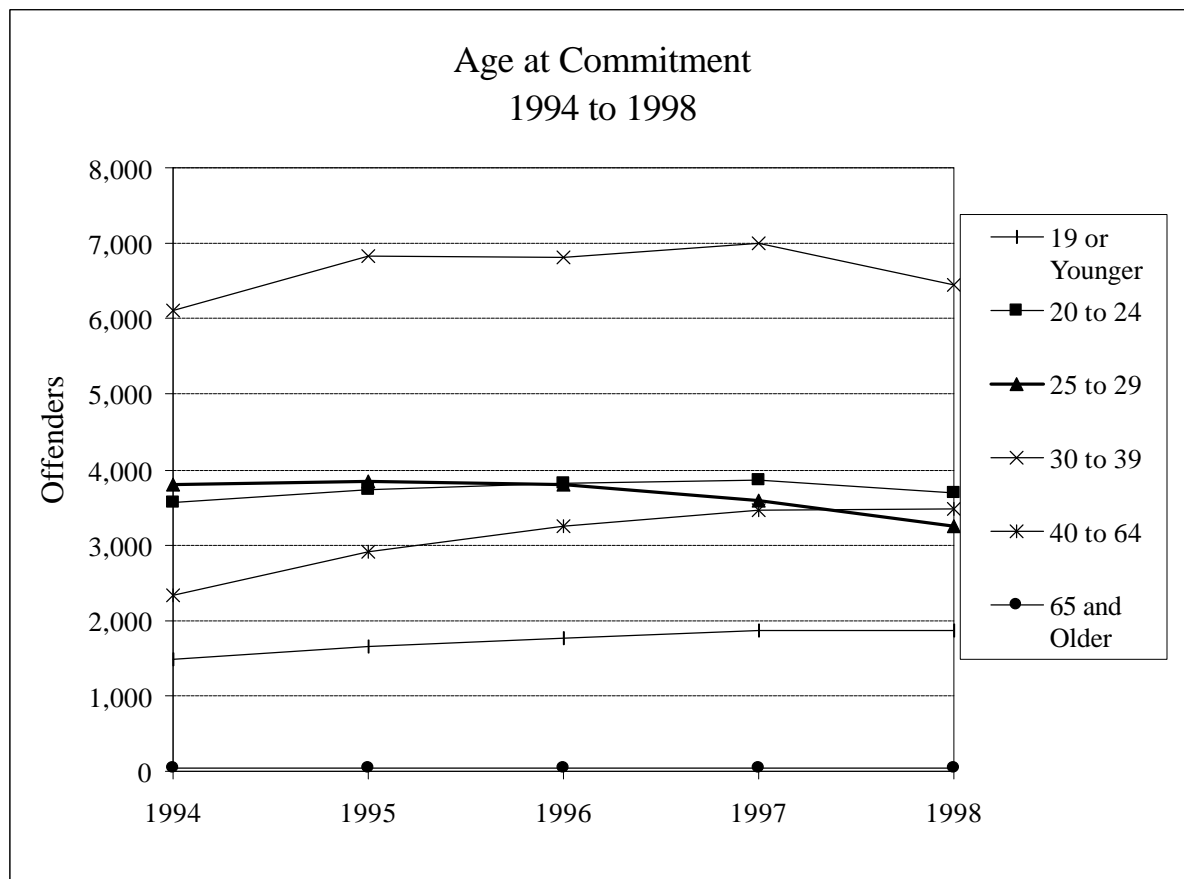

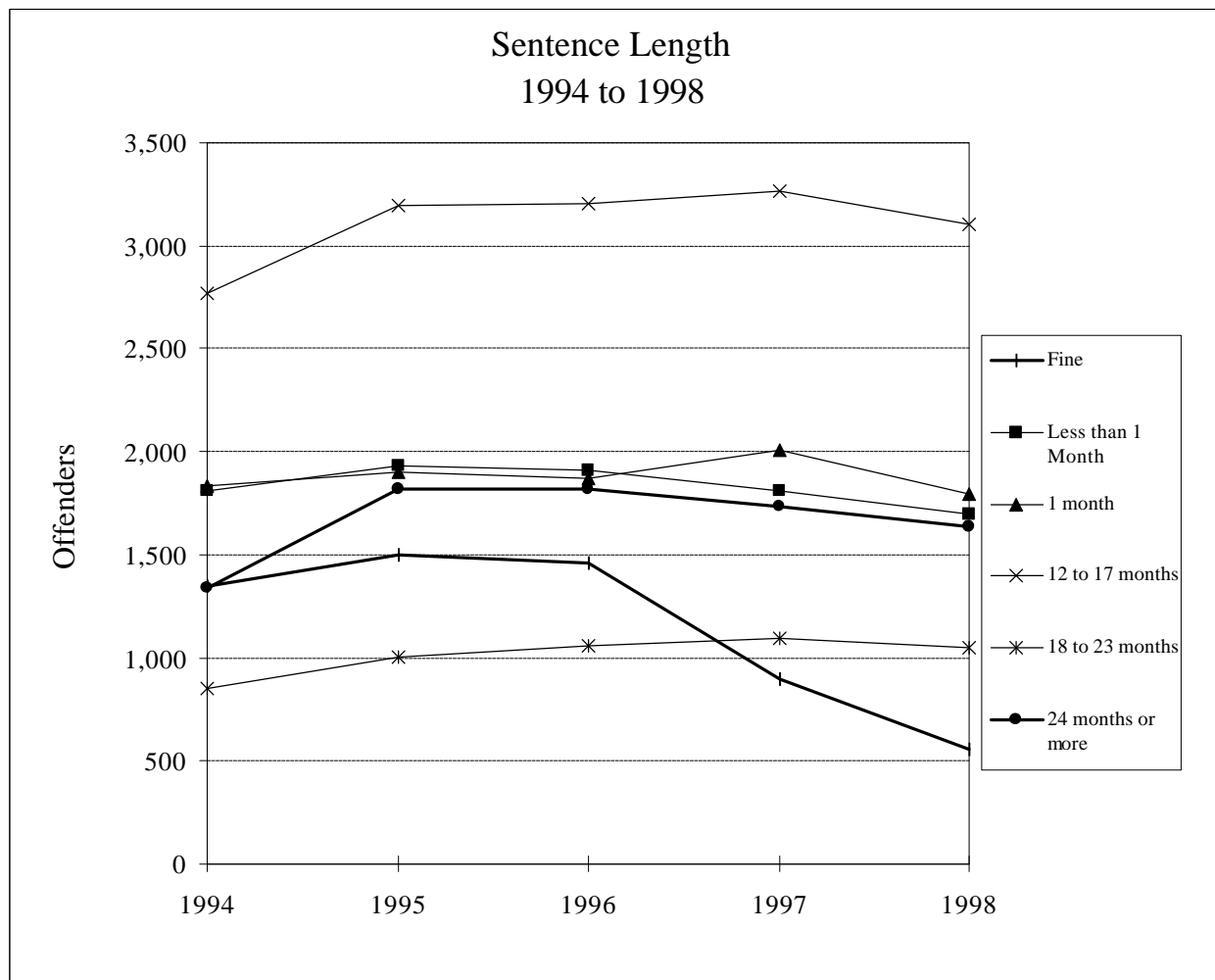

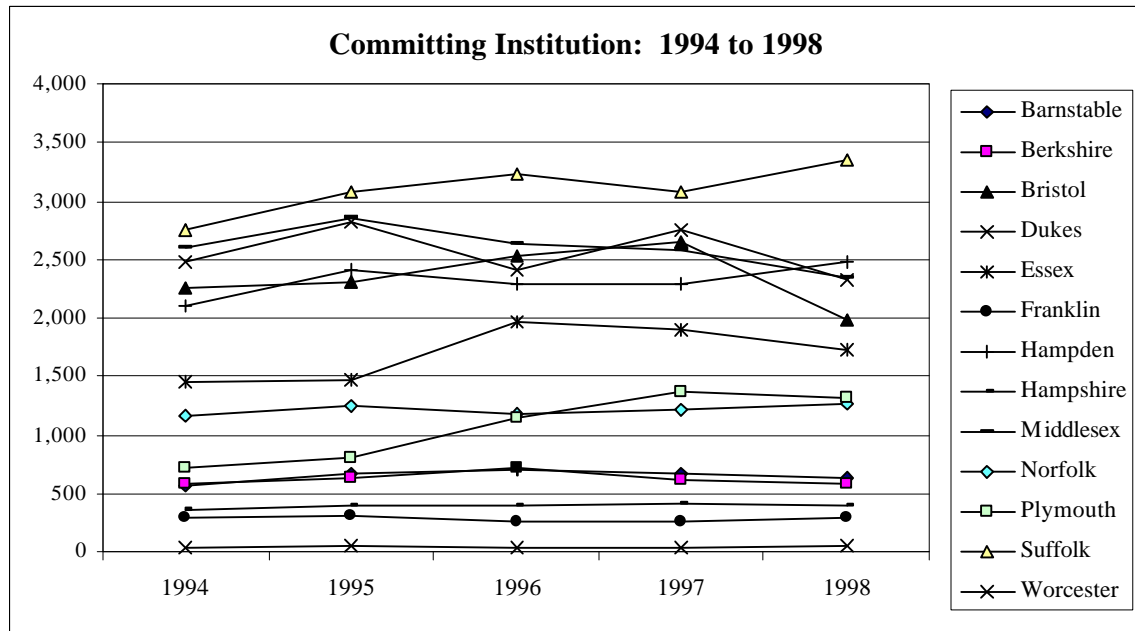
