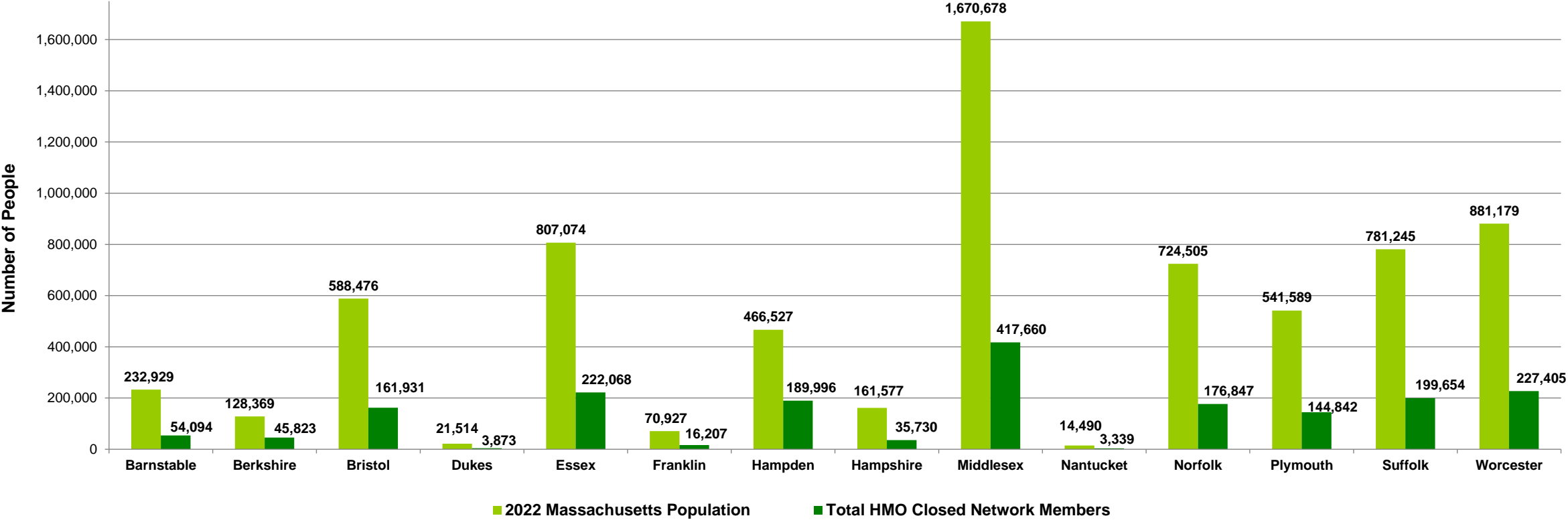

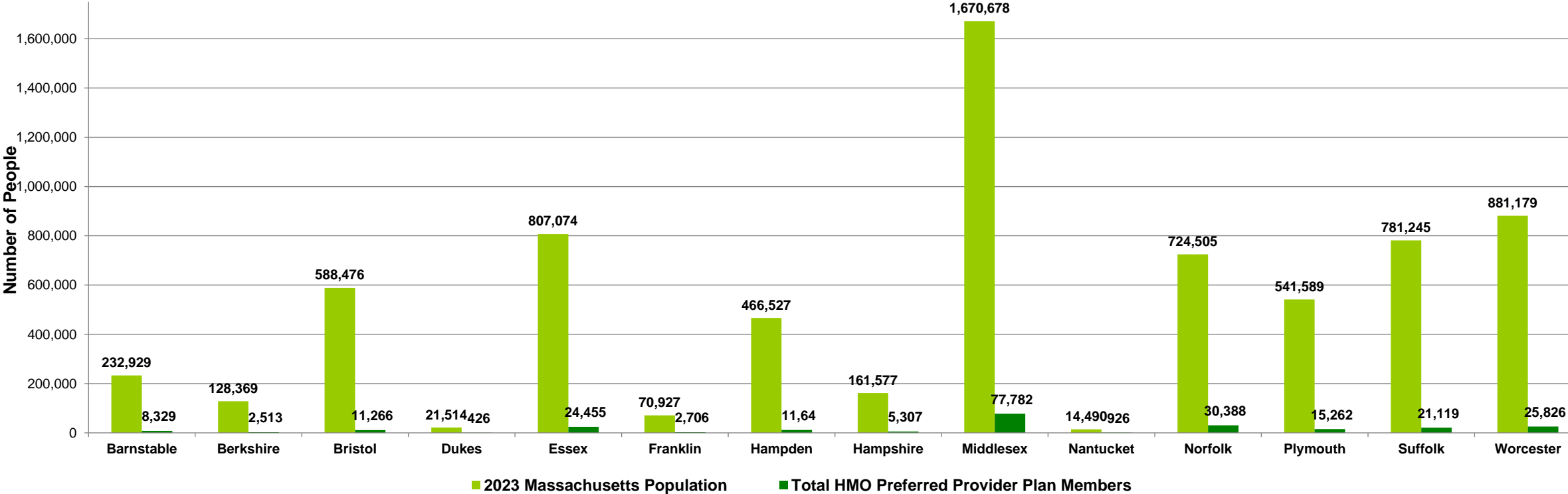
Total HMO Membership in Closed Network Plans vs. Massachusetts Population by County
