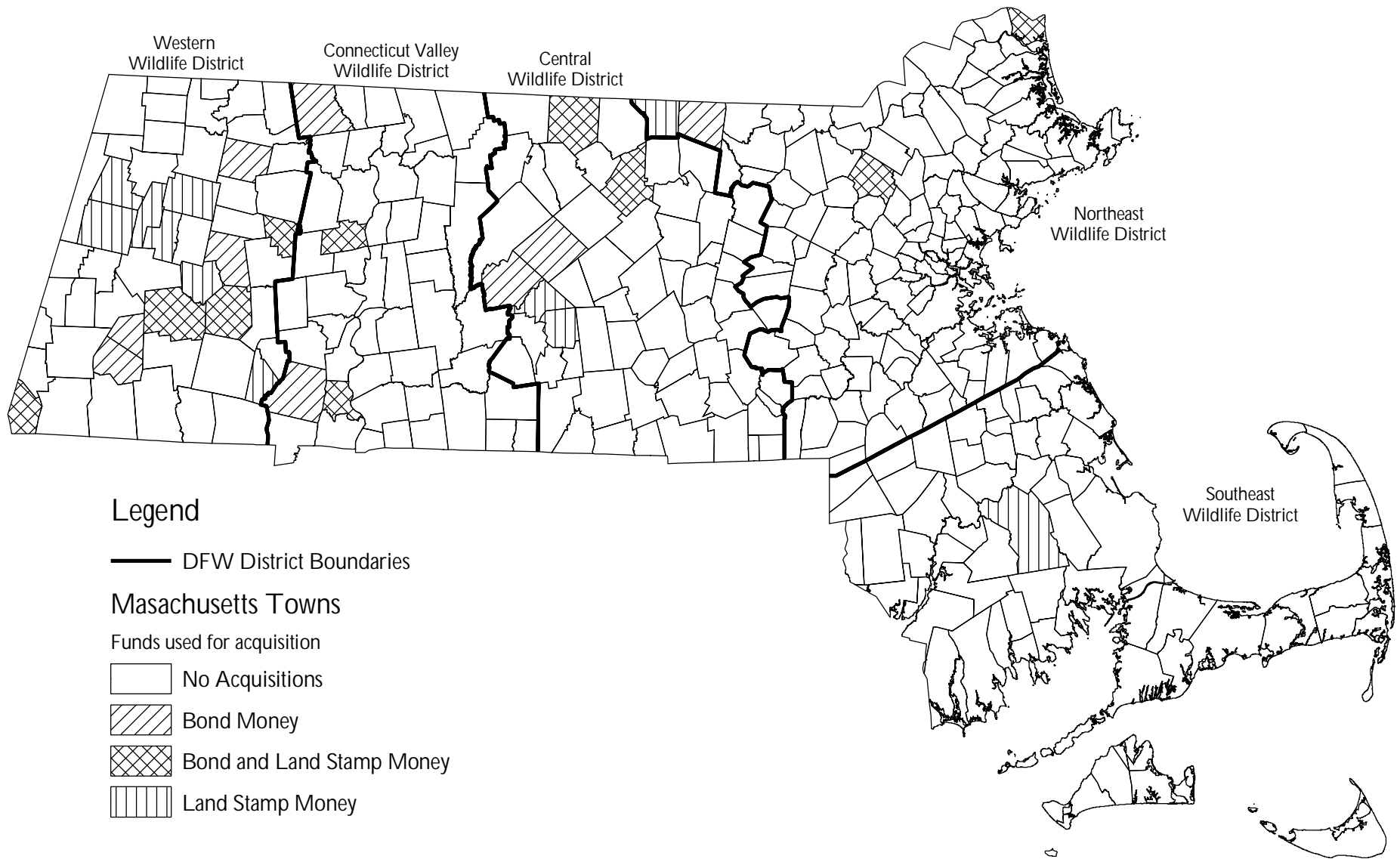


# Towns in Which MassWildlife Acquired Land in 2004

**Total Amount of Wildlife Lands Protected: 1410 Acres**

**WMA and NHA**—Wildlife Management Area and Natural Heritage Area: Land owned outright by MassWildlife. Open to the public for hunting, fishing and other passive recreation. **WCE**-Wildlife Conservation Easement: MassWildlife owns development rights on private property. Public access permitted. **ACCESS**—Property providing public access to waterbody.

**LS** = Wildlands Stamp Fund **B** = Open Space Bond funding
