Hopefully you are all enjoying a safe and wonderful summer. In preparation for PHASE I of the SAPHIRE (State-Aided Public Housing Intake and Referral Elements) program, we have scheduled training sessions for all Local Housing Authorities (LHAs). These sessions will provide you and your staff with the information needed to access electronic housing applications submitted by Housing Assistance Providers (HAP) on behalf of applicants via the Virtual Gateway.

Staff members from your LHA who need access to applications for homeless shelter residents and have been identified to use the Virtual Gateway Application Inbox must attend this training. A variety of class dates, locations, and times have been set up that we hope will make it convenient for your staff to attend training prior to system rollout.

Registration Procedures

Pre-registration is required. Classes are limited to the number of available seats at each training location. Registration is on a first-come, first-served basis. There is ample capacity to accommodate all LHA workers scheduled to go live in October, but classes will fill quickly and choice selection may be limited for those waiting to register later.

To register:

1. Identify the staff member(s) at your LHA that should attend
2. Identify which class each staff member would like to attend
3. Reply to this email message and include:
 - a. The name of your LHA
 - b. The number of staff members that will attend class
 - c. The class date, location, and time each staff member(s) wishes to attend training

You will receive a return email confirming staff enrollment. All registrations must be complete by September 15, 2006.
