Massachusetts Hate Crimes, 2007



Commonwealth Fusion Center June, 2008

Executive Summary

The 2007 Hate Crime report for Massachusetts was compiled using data voluntarily supplied from police departments across the Commonwealth, including 67 municipal agencies, transit police, and 15 campus police agencies. The Commonwealth Fusion Center's Crime Reporting Unit received a total of 350 reports, which included 586 criminal offenses within those cases.

Examining the 2007 submissions for hate crimes revealed that prejudice against race/ethnicity or national origin was the most widely reported bias motivation, representing 57.9% of the total. Bias against sexual orientation is second, with 24.5% of the total, and religious bias is third with 17.09% of the total.

Hate crime in Massachusetts for 2007 focused on specific victims rather than religious, ethnic or government symbols. Individuals were primarily the targets for bias crimes in the commonwealth, with 78.3% of the reports, while private property was targeted 11.3% of the time. Police cited public property in 2.03% of the incidents.

Notably, the female gender is on the rise as both the victim and offender with respect to hate crimes. In 2007 females comprised 33.2% of victims compared to 26.7% in 2006 (an increase of 24.3%), while they constituted 17.4% of offenders in 2007 versus 13.8% in 2006 (an increase of 26%). Echoing previous years, males were still the most frequent victims (66.8%) and offenders (82.6%) of hate crimes. Whites were also the most frequent racial category as victims (58.4%) and also as offenders (69.2%). Black victims of both genders composed 29.6% of the total population of victims. The average age of victims was approximately 31.5 years old. Offenders were somewhat younger than victims, with an average age of 26.1 years

Victims were reported to be injured in a small percentage of cases. Police officers investigating these incidents reported that in 71% of the cases where the information was provided there was no visible injury to the victim.

Bias incidents reported by police in Massachusetts occur in a variety of locations both public and private. In 2007 29.4% of incidents occurred on a highway or street, while an additional 28.8% occurred in a residence (a reversal of 2006, where residence was the primary location at 30.5%, followed by highway at 21.8%). An additional 11.3% were reported to have happened in a school or college in 2007, while approximately 2.6% of incidents occurred at religious sites such as churches or synagogues.

Specific types of bias motivations were reported to police departments as well. The largest category of bias incidents were determined to be anti-Black, with 33.3% of all incidents, or 121 of the incidents reported. Another 20.9% or 76 incidents were classified as anti-gay. Anti-Semitic and anti-white cases ranked third and fourth, at 16% and 11.6% respectively, in frequency of occurrence. While a great deal of media attention has been given to discrimination against the Islamic religion or persons from Arab countries, only 2.75 % (down from 4.7% of the 2006 cases) were classified as either anti-Arab or anti-Islamic.

Bias crimes entail a variety of different criminal offenses ranging from violent crimes to vandalism and harassment. In 2007, the significant portion of incidents involved vandalism (22%) with harassment (20%) and general civil rights (14.9%) following close behind. There were, however, 52 aggravated assaults reported.

The reporting system also captures information on the types of weapons used in the commission of the offense. Firearms were used in only 2 cases, accounting for less than 1% (0.64%) of the incidents, with knives or cutting

instruments used in 17 cases or 5.4% of the total. Hate criminals most often fought without weapons 50.8% of the time or were involved in fistfights where hands, fists or feet were used (24.3%).

Definitions

Hate Crime Any criminal act to which a bias motive is evident as a contributing factor. The

Reporting Act covers bias on account of race, religion, ethnicity, handicap, gender, or sexual orientation. Hate crimes can be reported only by law

enforcement agencies.

Zero Report An official report by a police department stating that no hate crimes were reported

to the department during the reporting period.

Non-reporting agencies Local police departments and other law enforcement agencies which are not in

compliance with the reporting provisions of the Reporting Act. These agencies have failed to indicate how many, if any, bias crimes occurred in their

jurisdiction.

Reporting agencies Local police departments and other law enforcement agencies which have

voluntarily reported the incidence of identified bias crimes in their jurisdiction. Agencies can comply with the Reporting Act by reporting the number of bias crimes, even if zero. Participating agencies which reported zero hate crimes for

2007 are separately listed.

Reports by Law Enforcement Agencies


Hate crimes were reported by 67 local police departments, transit police and 15 campus police agencies. These agencies had a total population of 2,967,912. A total of 350 hate crime reports were filed by these agencies, which included 586 criminal offenses and 363 bias motivations. [An additional 218 municipal police departments, 23 campus police agencies, 21 state police locations, five transit police locations, and one specialized agency reported zero hate crimes during 2007. These agencies had a total population of 3,094,423. Sixty-seven municipal police agencies and seven campus police departments did not participate in the hate crime reporting program. These agencies had a population of 286,762.]

In the report that follows, it should be noted that there may be multiple offenses, bias motivations, victims and offenders reported in each incident report. As a result, there are more responses than there are cases.

Categories of Bias Reported

Bias motivations break down as follows: of the 363 bias motivations for particular crimes reported, race/ethnicity/national origin bias constituted the largest category of reported motives, with 58% of the total. Offenses motivated by sexual orientation bias were the second most frequent category, with 24.5% of the total. Offenses related to religious affiliation were the third most prevalent, with 17%, while offenses against mental or physical handicap status were reported as 0.28% each of the total.


Bias Types



Categories of Crimes Reported

Of the total of 586 crimes reported, harassment and threats were the most frequent offenses, representing 29.4% of the total. Vandalism and destruction of property were the second most frequent offenses, representing 25.8% of the total (a decrease of 24.3% from 2007's 34.1%). Other frequent crime categories were general civil rights violations (14.9%), simple assault (12.3%), and aggravated assault (8.9%).


Crimes Committed During Bias Attacks



Victim and Offender Profile

Of the cases with valid information, a person was the target in 78.3% of cases. Private property was the second most frequent target of bias crimes with 11.3% of incidents. In a slight change from 2006, public property was third in 2007, with 2.3% of the cases. (Religious property was third in 2006 with 3.5% of the cases; however, it was fourth in 2007 with 2.0% of the cases).


Target of Hate Crime




The victim(s) of hate crimes (in cases where the victim's race was available) were white in 58.4% of cases, black in 29.6% of cases. The victims were male in 66.8% of cases. Of the cases where the victim (s)'s age was reported, the mean age was 31.5 years, with a median age of 33.2 years.

The perpetrator(s) of hate crimes were white in 69.1% of cases, and black in 22.4% of cases, in the 295 cases where this information was available. The perpetrator was male in 82.6% of cases, and had a mean age of 26.1 years and a median age of 29.4.


Victim & Offender Race

Characteristics of the Incidents

The majority of incidents occurred on a highway or street (29.4%) or in a residence (28.8%). Other locations where incidents occurred were schools/colleges (11.3%), parking lots/garages (3.8%), commercial/office buildings (3.2%), restaurants (2.9%), and religious facilities (2.6%).

Weapons of some type were used in 154 incidents. In cases where a weapon was identified, hands/fist/feet were used (24.3%) the majority of the time. "Other weapons" were listed in 14.4%, and knives were used in 5.4% of cases.
