Injuries are a leading cause of death and hospitalization among Massachusetts children. In 2012, there were 58 injury-related fatalities among Massachusetts children, a rate of 4.1 per 100,000 persons. Leading causes of injury deaths among Massachusetts children were suicide, motor-vehicle traffic accidents, homicide, and drowning.

This framework does not provide for intentionality for certain cause categories as indicated by gray shading.
