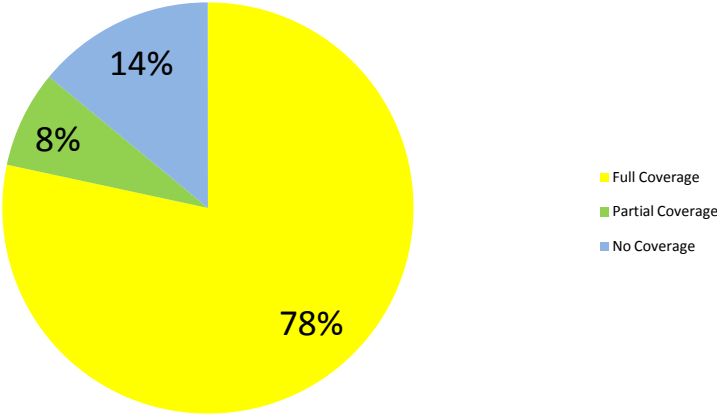

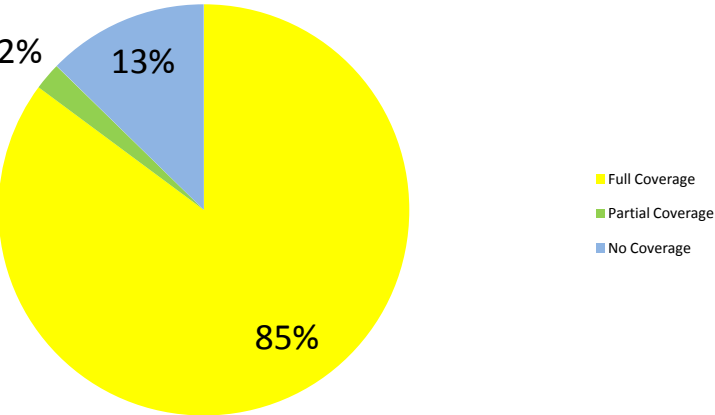

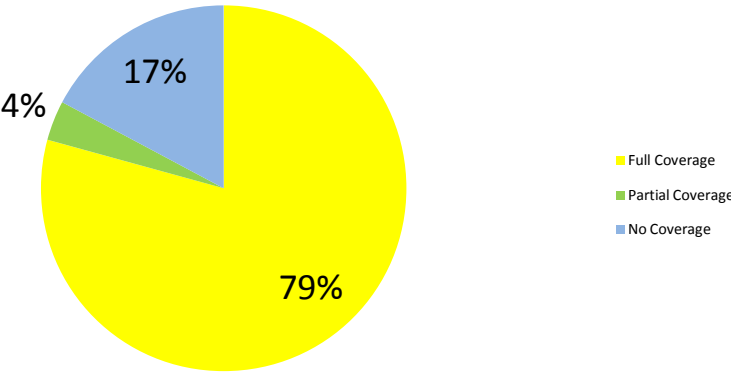

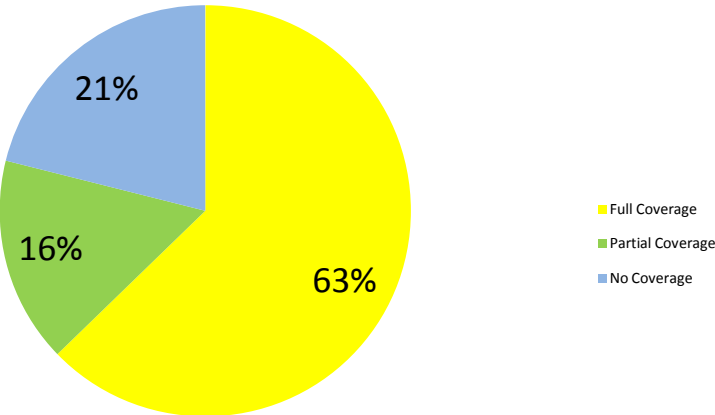
Hormone Replacement Therapy



Hypodermic Syringes or Needles in Self-Funded Plans

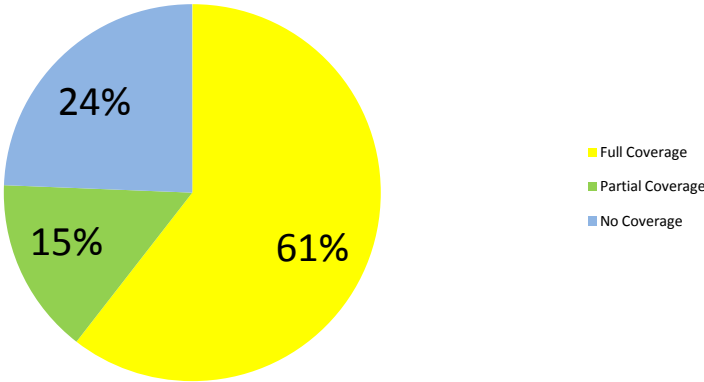


Infertility Treatment in Self-Funded Plans

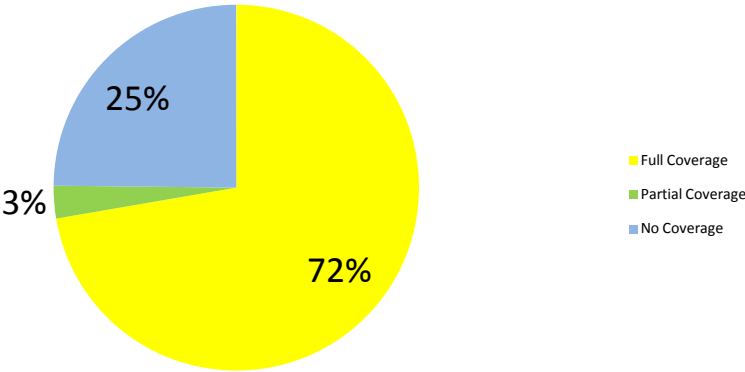

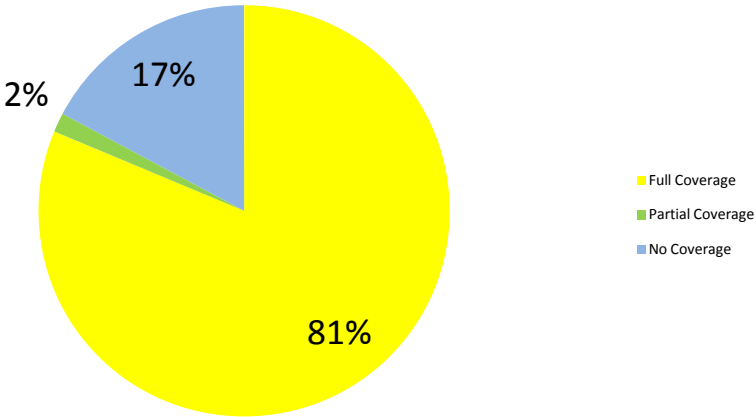
Low Protein Food Products for Inherited Amino Acid and Organic Acid Diseases (PKU)



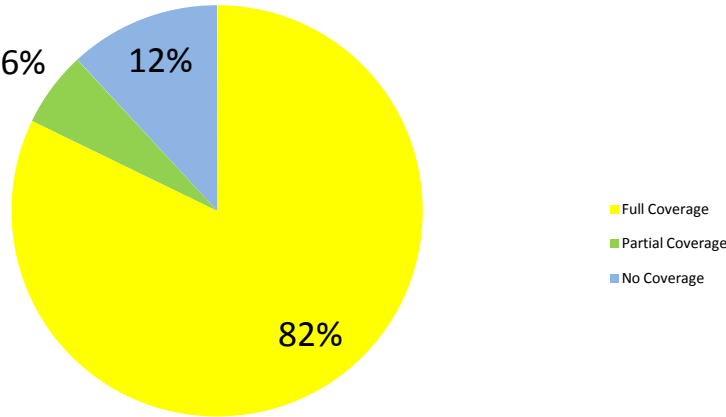
Nonprescription Enteral Formulas in Self-Funded Plans
