## Mandatory Nurse Overtime Background, Pursuant to M.G.L. c. 111, Section 226

Chapter 224 included provisions regarding Mandatory Nursing Overtime (MNO).

Mandatory Nurse Overtime (MNO) can only be used in "the case of an emergency situation where the safety of the patient requires its use and when there is no other alternative."

The Health Policy Commission was charged with determining what constitutes an "emergency situation."

The Department of Public Health was directed to receive reports about "all instances of mandatory overtime and the circumstances requiring its use."



## Mandatory Nurse Overtime Background, Pursuant to M.G.L. c. 111, Section 226

After the Health Policy Commission issued its guidelines, the Department of Public Health issued a circular letter providing instructions to hospitals about how to report Mandatory Nursing Overtime.

Reporting went into effect for instances of MNO occurring after August 1, 2013

Reports of instances of mandatory nursing overtime should occur within 30 days

The Department recognizes that this first year will be a learning curve for all parties and appreciates input from all stakeholders to make the reporting process and data collection efficient and helpful. The Department hopes that this data will also be useful to the Health Policy Commission in its deliberations.




### Preliminary Information: Summary

- For August and September 2013, DPH collected reports from DPH and DMH licensed hospitals as well as information from Commonwealth-operated facilities
- In total, for the two-month period, DPH received data from 20 Hospitals, with 118 total MNO events involving 178 nurses and 734.2 hours of mandatory overtime



### Number of Hospitals That Reported MNO Events by the Number of Events Reported for August and September 2013


 Of those hospitals that reported at least 1 event of MNO, 75% used it 5 or fewer times for both months combined





## Number of Nurses Involved per MNO Event for August and September 2013


- 71% of MNO cases involved only 1 nurse
- 3% of cases involved 4 or more nurses





## Number of Total Nurses Involved in MNO by Hospitals in August and September 2013

- 85% of hospitals\*
  reported 10 or fewer
  nurses involved in all
  MNO events in August
  and September
- 70% of hospitals\*
   reported 5 or fewer
   nurses involved in all
   MNO events in August
   and September




## Number of Total Hours Reported per Hospital for August and September 2013

- 55% of hospitals\* reported using 10 hours or less of MNO
- 40% of hospitals\* reported 5 or less hours of MNO
- 25% of hospitals\* reported more than 25 hours of MNO

### Type of Emergency

- Pursuant to Health Policy Commission guidelines, an "emergency situation" is a:
- A)Government declaration of emergency;
- B)Catastrophic event; or
- C)Hospital Emergency.
- "Hospital Emergency" was the type of emergency provided for the MNO in all reports

- The Department is continuing to collect data on MNO and appreciates the effort on the part of hospitals to report.
