Area OCLMA: All 2013 trap tags must be attached to your gear by March 16, 2013. Please order by <u>JANUARY</u> to allow process & delivery time.

To process your order for tags, you **must** provide the following:

- Completed official order form
- Photocopy of current Massachusetts Commercial Lobster License
 - ***You do NOT need to renew your permit prior to ordering tags***
- Photocopy of current Federal Lobster Permit, if purchasing EEZ or MA/EEZ tags.
- Completed Tax Exemption Certificate from the state of Massachusetts (see reverse side).
 - *Tax exempt orders received without a Tax Exemption certificate will be charged sales tax.
