

Injury Fatalities among MA Children Aged 0-17 years¹

2015

Injuries are a leading cause of death and hospitalization among Massachusetts children. In 2015, there were 53 injury-related fatalities among Massachusetts children, a rate of 3.8 per 100,000 persons. Leading causes of injury deaths among Massachusetts children were suicide, homicide, motor-vehicle traffic accidents, and drowning.

Injury case definition: An injury-related fatality is defined as any death with an ICD-10 code of U01-U03 or V01-Y89 in the underlying cause field. Injury mechanism/intent categories are based on the CDC *Recommended framework of E-code groupings for presenting injury mortality and morbidity data*. This framework does not provide for intentionality for certain cause categories as indicated by gray shading.

- 1) Includes MA residents who died in or out of state.
- 2) Includes injuries resulting from police actions, terrorism and war.
- 3) Crude rates per 100,000 MA residents; based on the 2015 postcensal estimate for the 2015 MA population aged 0-17 years of 1,387,087 (U.S. Census Bureau). Rates provided here are not age-adjusted and may differ slightly from other department publications. Rates are not calculated on counts of less than five. Rates that are based on counts less than twenty may be unstable.
- 4) Total may not sum to 100% due to rounding.
- 5) Includes asphyxiation and hanging.
- 6) Transport includes several subcategories (shown in italics). These are not included in the overall totals.
- 7) Includes motor vehicle drivers and passengers.
