To DCR staff:

We are writing to submit our comments on the above public meeting that took place on October 1st. We are pleased that the DCR has undertaken this series of public meetings. This area of Perkins and Parkman has been under discussion for many years and we are happy to see it move forward.

- We were pleased to see the proposal for a signalized intersection at Parkman and Perkins and agree that the tightening of the corner is crucial to slowing traffic down at the intersection for the safety of all. We wondered if you had looked at striping a crosswalk at the Sargent Crossway side of the intersection where pedestrians may tend to cross where westbound traffic is stopped at the light.
- We noted many comments at the meeting about the issue of bike lanes on Perkins and Parkman and urge you to review the existing bike lanes to improve their safety. The entire stretch should contain a continuous bike lane rather than the stop and start of current conditions. You've heard requests that a bike facility be created along Prince or Parkman to connect the Arborway/Jamaicaway & Perkins St. at this end of Jamaica Pond (and to make it possible to bike around the Pond). It isn't within the scope of this project, but it would pass through the intersection of Parkman & Perkins. We want to make sure it is part of the system-wide review of adding bike facilities to the parkways.

Again, looking at bicycle accommodations, one suggestion we heard that deserves consideration is looking at the buffered bike lane that would be created if the parking lane & bike lane were switched.

We also look forward to seeing this issue addressed in revised plans and discussed at a later meeting.

We also heard comments regarding the sidewalk on the opposite side of Perkins St to Jamaica Pond. We understand that it is not part of the scope of the project but with no sidewalk on the Pond side the idea of improving the condition of that sidewalk seems worthwhile.

The LivableStreets Alliance is pleased to provide comments for the Jamaica Pond Access Enhancements at Perkins Street and Parkman Drive presented by DCR and BETA Engineering on October 1, 2015.

The LivableStreets Alliance believes that the enhancement goals "To provide safe, convenient access between the north side of Perkins Street and Jamaica Pond" fall short of DCR's stated meeting purpose to "present results of traffic study to improve pedestrian and bicycle flow to Jamaica Pond". The alternatives presented do not meet Complete Streets standards and need to be redesigned to accommodate both pedestrians and cyclists while calming motor vehicle traffic.

After reviewing the October 1st Presentation we recommend the following changes:

- Eliminate the slip lane, pork-chop island and right turn lane heading northeast on Perkins. The Queue length diagram indicates that there is no need for the slip lane. Slip lanes decrease pedestrian safety, increase crossing distances, and do not help to calm traffic.
- Extend the bike lane heading northeast on Perkins to the intersection and provide a dashed bike lane through the actual intersection.
- Reduce the lane width to 10'-0" and reduce both the median width and length to help calm traffic by reducing traffic speed. Use the narrower roadway to increase sidewalk width.
- The sidewalk width on the north side of Perkins Street is narrow and there is no sidewalk on the Pond side of Perkins Street from Parkman Drive to Chestnut Street. The project should increase the width of the existing sidewalks.
- We support both the new path at the intersection and the optional path to improve safe and convenient access to Jamaica Pond. The optional path is a pedestrian desire line and will reduce foot traffic on the slope. We also support the new mid-block crossing, the new stairs and ramps.
- Reduce lane width on Francis Parkman Drive to help reduce traffic speeds.
- Install bike lanes extending to the intersection on Parkman Drive within the project limits so that people on bikes can avoid the queue of cars and make the right turn without crossing the path of motor vehicles. This is both safer and more convenient for both motorists and cyclists.
- Install a bike box on Parkman Drive at the intersection so that people on bikes can make a left turn from Parkman Drive to Perkins Street.
- An option to provide a separated (protected) bike lane on Perkins Street southwest of the intersection should be studied. Separated bike lanes have been shown to both increase safety and bike ridership. One obvious method would require the parking lane to move towards the median and to place the bike lane between the parked cars and the sidewalk. Separate the bike lane from the parking lane with flexible bollards or a mountable curb. Install signage to keep cars from parking in the bike lane. The travel lanes or medians would have to be narrowed to provide the required buffer between the parked cars and the separated bicycle lane.

• As part of a future project, the DCR should consider adding a sidewalk to the pond side of Perkins Street to allow people to exit their cars and walk safely to the pond.

The Massachusetts Department of Conservation and Beta Engineering are to be commended in their efforts to improve accommodation to Jamaica Pond and we look forward to seeing the design develop and the project be built. These comments are submitted in support of a pedestrian access plan for Perkins Street in Jamaica Plain presented at a public meeting on October 1, 2015 which I attended.

This plan, which calls for the installation of two traffic lights and crosswalks on Perkins Street to provide pedestrian safety between Cabot Estate and Jamaica Pond, is essential to the safety of the residents of Cabot Estate. The development, of 158 units, houses both families with children and elderly residents such as myself. The total population numbers several hundred people. It was built in the 1970s, but *has been without a crosswalk on any side of its 22 acres since its construction*. Perkins Street, where the proposed crosswalks would be installed, is a wide and heavily trafficked street and the current situation requires that those seeking to cross it dodge traffic in 2 directions without proper lines of sight. Cars move swiftly along the street at all hours of the day. It is extremely dangerous and is (another) accident waiting to happen.

Residents and others have been trying to secure a crosswalk for at least 17 years. The proposed plan, for which we understand DCR funding is allocated, should be completed without further delay. Pedestrian access is a fundamental component of any traffic management plan. Any other suggested enhancements should be considered only after this fundamental element is completed.

As I understand it, this matter was the subject of a public meeting in 2012 or 2013 and residents had been under the impression that the crosswalks were to have been constructed by now. Hopefully this long-delayed project can now move forward expeditiously.

We are writing to express our hope that as many mature trees and significant landscape features, as possible, are preserved during the design and construction phases of this project. In future iterations of the plans, we feel that it is essential to fully document the following: 1) exact tree locations and sizes, 2) tree species identification 3) graphic representations of tree canopy spreads, 5) existing contours (one or two foot intervals), and 6) site structures such as historic walls and retaining walls. Mapping these features will serve to more fully inform the configuration of the proposed traffic improvements.

Existing landscape features are integral to the character of the historic parkway. This is particularly true of the stately trees that do so much to define the parkway. When the proposed roadway alignments are superimposed on the existing road system, it appears that a number of significant trees may be impacted, particularly at the Murray and Kelley roundabouts. While replacement trees will undoubtedly be a part of any scheme, it is the existing continuous canopy of mature large trees that effectively provide the highest environmental value and lend the historic parkway its unique aesthetic character.

We appreciate the opportunity to weigh in and we look forward to following the evolution of the plans for the roadways. We are confident that it will be possible to marry the goals of traffic safety with those of preserving of the parkway's beloved historic and natural resources.

Because of the volume and speed of traffic passing through that intersection and along Perkins Street, it is often quite dangerous for pedestrians to cross, especially during rush hour. As you are aware, in 2010 a pedestrian was seriously injured while crossing at Cabot Estates. There are regularly near misses for pedestrians and bicyclists.

We support the proposal to install the crosswalks as illustrated on Page 13 of the proposal submitted to DCR by the Beta Group. We also support the construction of paths leading from the crosswalks to the Pond, to eliminate the current necessity for pedestrians to climb over the guardrail (and the snow bank in winter) and then to walk down the slope to the Pond on the grass, which is often muddy or slippery. Foot traffic on the slope also causes erosion and runoff of soil into the Pond.

Thank you for your work on this project. We look forward to its successful completion and to the continued opportunity to enjoy Jamaica Pond, without having to experience the stress of dodging cars and trucks in order to get there!

To the Department of Conservation and Recreation,

The Boston Cyclists Union (BCU) is pleased that the DCR has undertaken a redesign of critical Arborway corridors and access to the Emerald Necklace. However, we were dismayed to see that the first draft design for the junction of Perkins Street and Parkman Drive had no bicycle accommodation at all. Contrary to a dying belief, bicycles are not merely a tool for recreation. Cyclists in the region, more than ever before, rely on biking for transportation (City of Boston just released a report showing a 104% increase in cyclists in 2015 since 2007). The DCR should embrace and support this mode shift, as it helps with fossil fuel reduction important to conservation, and touts health benefits that we know are important to the DCR in its mission to promote recreation and improved public health.

Not only is the Emerald Necklace a destination, but a critical corridor for commuters, who bike through from Roslindale, West Roxbury, Newton, Brookline and Jamaica Plain to gain access to the rest of Boston, to the Longwood medical area, to school, work and play. We have over 2,300 cyclists from those neighborhoods who are engaged and want to see real accommodations for cyclists along the Emerald Necklace. We know you heard from many of them at the meetings and through letters. Just like us, they want to see DCR calming traffic along these roads where high speed car travel is a serious issue threatening safety of cyclists and pedestrians; they know, just as we do that a single car parked in a bike lane puts cyclists in immediate danger having to navigate around and into traffic; and that protected bike lanes and real infrastructure to accommodate cyclists is needed along all roadways that you are managing and re-thinking, especially those in your multi-modal improvement plan.

We appreciate that Patrice Kish of the DCR reached out to our board member Peter Furth with the commitment that the DCR and Toole would be revising the design to account for the needs of cyclists and would seek BCU input in this process this fall / winter. This is an important corridor for bicycling and it is important that this project avoid any construction that would preclude good bicycle accommodation in the future, such as making a corner so tight that it would squeeze out a future bike lane. Is is also important that a project like this seize every opportunity to improve bicycling safety by adding bike lanes and / or converting bike lanes to cycle tracks where possible.
