Notes for Section 1: 1) While the epinephrine administration data in sections 2 and 3 are the main focus of this report, allergy prevalence and epinephrine prescription data are included here to put those administrations in context. Note that the allergy and prescription data are only available for public school districts affiliated with the Essential School Health Services program, and while these data include more than 60% of the state's public school population, they may not be representative of the entire state. 2) Charter schools and collaboratives are counted as districts for purposes of this report. 3) For consistency, the allergy prevalence and epinephrine prescription rates that are shown in the table only include districts that reported data in both categories. 4) For calculating allergy prevalence, a student may be counted as having an allergy even if that student has never experienced an anaphylactic reaction.

Notes for Sections 2 and 3: 1) These data show the number of epinephrine administrations due to suspected anaphylactic events. 2) These data are compiled from reports of epinephrine administration submitted by public and private schools throughout Massachusetts, and are not limited to schools participating in the Essential School Health Services program. 3) An online data collection tool is used to faciliate the collection of epinephrine administration data. 4) "Other" race/ethnicity includes American Indian/Alaskan Native and Native Hawaiian/Other Pacific Islander. 5) "Not reported" indicates that the respondent skipped the question or failed to complete the questionnaire, and as a result, nothing can be inferred from the answer. "Unknown" is a response option, however, and indicates that the respondent answered the question by selecting "unknown." If a response was "not reported" it is also "unknown," but not all "unknown" answers are "not reported."

Note for Sections 1, 2, and 3: Percentages may not sum to 100% due to rounding.
