2016 Zero Emission Vehicle Credits

Manufacturer Volume Status

The Zero Emission Vehicle (ZEV) Regulation requires large and intermediate volume vehicle manufacturers to deliver and place in service within Massachusetts (MA) a certain percent of ZEVs (such as battery electric and fuel cell vehicles), clean plug-in hybrids, clean hybrids and clean gasoline vehicles with near-zero tail pipe emissions. The table below lists the 2016 vehicle manufacturers subject to the ZEV requirements.

Manufacturer Credit Balances

In complying with the ZEV Regulation, manufacturers delivering and placing vehicles in MA generate varying credits based on vehicle type. The credits are in units of ZEV credits (2012 and prior, credits were expressed in grams per mile non-methane organic gas [NMOG]).
