OVERVIEW

FELLOWSHIP PROGRAM

The annual HPC Summer Fellowship Program has the dual purpose of helping to achieve the Commonwealth's goal of health care cost containment while simultaneously providing hands-on educational opportunities to the next generation of health policy leaders. Each year, the Fellowship Program affords students the opportunity to engage in a ten-week, stand-alone policy or research project with one of the HPC's six departments (see page 2). Treated as regular employees, Fellows manage their own time to ensure they meet outlined project benchmarks and deliverable deadlines, and to design and give key presentations.

PEOPLE

Applicants are required to be enrolled in a full-time bachelor's, master's, PhD, law, or medical program. Undergraduate applicants are required to have completed at least three years of their bachelor's degree. For the 2017 Fellowship Program, the HPC received over 200 applications from over 65 different universities across the world. After reviewing applications, HPC staff conduct interviews with dozens of top applicants. Interviews require applicants to describe their skills as well as propose a project of interest to them based on outlined workstreams.

STIPEND

In 2017, Fellows were paid \$15 per hour for up to ten weeks (375 hours). To enhance their time with the HPC, Fellows were included in various activities and meetings and given access to some of the Commonwealth's most cutting edge and forward-thinking policy making processes.

PROGRAMMING

On a day-to-day basis, Fellows worked in conjunction with their teams to see a project from creation to completion, while also exploring the intersection of HPC goals and their own academic interests. In addition to their main projects, Fellows were also offered a host of programming and networking opportunities to allow them to better understand the varied facets of the HPC's work. Examples included:

- Joining policy meetings with HPC staff and key stakeholders
- Completing "speed networking" and career advice events with HPC staff
- Attending HPC public Board and Committee meetings
- Participating in small, interactive meetings on health policy with the HPC's Board Chair, Executive Director, and Commissioners
- Engaging in meetings with the HPC's Leadership Team

HPC TEAMS

ACCOUNTABLE CARE

The Accountable Care (AC) Team is responsible for fulfilling the HPC's statutory charge (1) to develop and implement state certification programs for Patient-Centered Medical Homes (PCMH) and Accountable Care Organizations (ACO), (2) to promote the integration of behavioral health with primary care, and (3) to enable policy reforms to support these care delivery models. The team works to advance accountable care through other avenues, such as enhancing data transparency, convening key stakeholders to better align models, and identifying key barriers and accelerators of reform.

RESEARCH AND COST TRENDS

The Research and Cost Trends (RCT) Team is responsible for developing an annual cost trends report to measure progress in key areas and examine performance against the health care cost growth benchmark, established to curb health care spending in the Commonwealth. This team is also responsible for building the HPC's evidence-base and supporting policy development and recommendations through the use of innovative data sources.

MARKET PERFORMANCE

The Market Performance (MP) Team performs a variety of market oversight functions including the comprehensive and evidence-based reviews of the impact of significant provider transactions on health care costs, quality, and access through the Notice of Material Change and Cost & Market Impact Review processes. The team also manages and analyzes the first-of-its-kind Registry of Provider Organizations (RPO) Program.

STRATEGIC INVESTMENT

The Strategic Investment (SI) Team is responsible for administering the HPC's Community Hospital Acceleration, Revitalization, and Transformation (CHART) and Health Care Innovation Investment (HCII) programs, two competitive grant programs that combine investment and consulting services in order to improve performance of the health care system.

OFFICE OF THE GENERAL COUNSEL

The Office of the General Counsel (OGC) is responsible for building and maintaining compliance infrastructure and developing the agency's regulatory program. The OGC's legal counsel advises on a wide range of strategic, policy, and operational issues.

OFFICE OF THE CHIEF OF STAFF

The Office of the Chief of Staff (OCS) manages the agency's day-to-day operations, strategic planning, and external affairs, including all media, public, legislative, intergovernmental, and stakeholder relations. Administration oversight of the HPC includes office operations, personnel and human resources, fiscal management, special projects, public events, and the Summer Fellowship Program.

This summer at the Health Policy Commission was an amazing experience that allowed me to fuse my passions for public service and policy with my interest in the health care field. As a master of public policy student, much of my coursework has revolved around general aspects of the policy process in broad issue areas. My fellowship at the HPC, however, allowed me to independently engage with multiple areas of health care policy at the state level.

As a fellow on the **Research and Cost Trends** Team, I worked on a project preparing for a legislatively mandated study on the topic of "white and brown bagging" of oncology drugs. Through this project, I conducted an extensive literature review on how oncology drugs are priced, the distribution and supply channels for these drugs, and the potential benefits and costs of implementing mandated "white and brown bagging" practices. My work will be used to conduct and finalize the "white and brown bagging" study due in July of 2018. I was also fortunate to work on a collaborative project between the Research and Cost Trends and Market Performance Teams on provider price variation across Massachusetts for injectable chemotherapy drugs. This project allowed me to cultivate my quantitative skills through analysis and data visualization platforms, which I did not have exposure to before this summer. My projects taught me about drug pricing as well as the complexities of the oncology drug market and the growing policy implications of these systems.

The past ten weeks were truly exciting, challenging, and different every day thanks to the fantastic team at the HPC who organized numerous events for us with the Commissioners, senior staff, and other stakeholders in the Commonwealth. I am extremely grateful for this opportunity and I will certainly take the amazing skills and knowledge I have learned at the HPC with me in my future health policy career. The Summer Fellowship at the Massachusetts Health Policy Commission (HPC) was an outstanding and unique introduction to the positive impact that can be had in state government. As a fellow on the **Strategic Investment** Team I performed a qualitative analysis to identify the successes and challenges experienced by CHART Investment Program awardees, all of whom are working toward value based care delivery while ensuring continuity for their patients even outside the walls of the hospital. It was very interesting to learn what methods did and did not work in care delivery transformation and population health management initiatives across Massachusetts. To that end, the HPC encouraged me to explore the hospitals in-depth by attending conferences, CHART hospital technical assistance sessions, and regional convenings. My time as a summer fellow has been both informative and rewarding. While working on the **Research and Cost Trends** Team, I had the opportunity to learn from the knowledgeable staff, hone my technical skills, and collaborate on meaningful and thorough health policy research. As someone neither from nor studying in Massachusetts, it has been an enlightening experience to learn about a new and unique state health system. Additionally, it has been exciting to work in a state agency that has the ability to transform research into practical policy recommendations in an effort to increase quality and decrease costs associated with health care in the Commonwealth.

I worked on the low-value care (LVC) project this summer using the All-Payer Claims Database (APCD), which is comprised of health insurance claims data for the three largest commercial payers in Massachusetts. This project started in 2016 in an effort to identify the amount of LVC being offered in the Commonwealth. Building off of the 2016 Cost Trends Report, my project included two main components: (1) measuring the costs that are associated with LVC provided in 2013 and 2014, and (2) analyzing the amount of high-value care provided in the Commonwealth in 2014 and comparing those findings to rates of LVC.

I am certain that my time at the HPC has assisted me in improving my research skills and has provided me with new knowledge that is crucial for my professional growth. I am thankful for the Research and Cost Trends Team, the Fellows, and the rest of the HPC staff for providing a meaningful and memorable summer experience.

During my fellowship at the Massachusetts Health Policy Commission I worked as part of the **Accountable Care** Team to develop a survey assessing treatment availability for individuals with co-occurring mental illness and substance use disorder. I combined recommendations from evidence-based research to help build a survey tool and report outlines tailored to the provider landscape in Massachusetts. It was rewarding to utilize concepts and methodologies from my Master in Public Health coursework to implement a legislative mandate. Working to assess a complex network of providers, the fellowship allowed me to think creatively about questionnaire development, data limitations, and incorporating provider feedback.

Improving patient outcomes through holistic care requires a multifaceted approach. Having previously worked in public health and psychiatric research, I was thrilled to join a team dedicated to behavioral health integration, access, and quality. Fellows were regularly included in strategic planning, internal presentations, and interagency meetings. These interactions provided me with valuable insights into both the diverse challenges as well as the opportunities that arise when building a health care system that is truly accountable to population health outcomes.

The Health Policy Commission encouraged fellows to engage across the organization's multidisciplinary teams, allowing us to see how the HPC's wide array of initiatives work together toward a common goal. Every week seemed to bring a new presentation, discussion, or meeting that deepened my understanding of health policy. I am extremely grateful to have spent my summer working in such a collaborative and mission-driven environment.

Reflecting on my summer as an HPC fellow, I am struck by how much this experience has expanded my professional horizons. While I had hoped to gain some exposure to state government and policy research, I am coming away with much more. With encouragement from my team, I was able to take ownership of my research project, gain valuable hands-on experience, and connect with people across the healthcare landscape in Massachusetts. Not only that, I am coming away with a deeper and more nuanced understanding of the intersection of research, policy and care delivery.

As a fellow on the **Strategic Investment** Team, I worked to develop two qualitative case studies of programs at CHART Phase 2 hospitals. The team provided regular guidance and support, and valued my input as we developed our focus and carried out the research process. One project focused on a program that coordinated outpatient care for pregnant women with opioid use disorder. The other examined the collaboration between two drug courts and community hospital treatment providers. I was able to dive deeply into both subjects and build on my qualitative research skills as we developed research questions, conducted interviews, analyzed qualitative data, and drafted an academic paper.

Being a health policy student, it has been rewarding to see the connection between my academic and professional work, and the direct impact that the HPC has on care delivery in Massachusetts. I particularly valued the opportunity to meet with staff across the HPC and members of the Board who shared a wealth of experience and expertise. I also learned from the other students in my cohort, whether we were sharing about our projects, discussing relevant policy issues, or debating the best place to get a cookie. My literature review examined the evidence supporting the integration of behavioral health into primary care, with a focus on measuring quality, cost, and utilization outcomes. My findings will assist the team in drafting future program materials and demonstrating the value of PCMH PRIME Certification to stakeholders. In addition to this research project, I assisted with program operations through participation in regular meetings to strategize approaches for marketing the PCMH PRIME Program to primary care practices and drafting PCMH PRIME communications.

I also worked on analyzing the Community Benefits Reports collected by the Attorney General's Office (AGO) from Massachusetts nonprofit hospitals and HMOs. More specifically, I examined key trends among the community benefits programs of hospitals across the state and highlighted implications for the HPC's ACO Certification Program. My research of the AGO report enabled me to gain a deeper understanding of the care delivery landscape in Massachusetts and learn about how the Community Benefits Reports align with the HPC's efforts to encourage hospitals to reduce health disparities by focusing on vulnerable and high-need populations.

Additionally, I was able to engage in many unique initiatives across the agency, including sitting in on meetings with HPC Commissioners, attending meetings on quality alignment measurement efforts across the state, networking with staff across departments within the agency, and touring the State House. Overall, I learned a great deal about various health policy initiatives in Massachusetts. It was refreshing to spend this summer working at the HPC, a truly independent, nonpartisan organization solely driven by facts. The bright and enthusiastic staff's ability to come together from diverse professional backgrounds to make an efficient and effective agency is inspiring.

As a fellow on the **Market Performance** Team, I had the opportunity to work on the first-in-the-nation Massachusetts Registration of Provider Organizations (RPO) Program. This program gave me an in-depth understanding of the structure of the Massachusetts provider market. My main project this summer focused on elements for expansion for the 2018 filing. I researched advanced practice providers and developed data elements to add to the current physician roster to better understand the role they play in the provider landscape. I also researched facility fees and created data elements to add to the facilities file to better understand the practice of facility fee billing. Furthermore, I had the opportunity to assist on the performance improvement plans (PIPs). I populated fact sheets and learned about the analysis process of an entity's performance to determine if it necessitated a PIP.

In addition to the projects the fellows worked on, we were invited to attend Board and Committee meetings to learn about the diverse policy research and projects implemented by the HPC. We met with Commissioners and other staff members to learn about their roles and the paths that led them to their positions. Hearing about their experience, in combination with my own experience here, has helped to illuminate the path I would like for my own career.
