#### **Dear Commissioner Gladstone:**

The attached 2018 Annual Report of the Designer Selection Board is filed in accordance with Chapter 7C, Section 56. This Annual Report lists all finalists selected by the Board during this period including a summary of the actions taken and a description of other relevant activities. Twenty-two formal meetings were held during this period. In addition, the Board conducted extensive interviews with semi-finalists, and new or reorganized, design firms and participated in conferences and other activities.

The "Executive Narrative" outlines the Board's accomplishments, actions, and other developments which have had an impact on the conduct of our business. The office staff spent considerable time responding to questions from architects, engineers, and municipalities on designer selection procedures and specific inquiries on DCAMM projects, past, present and future.

This Board's responsibility as the central administering body for selection of all designers for vertical building construction projects throughout the Commonwealth necessitated direct involvement in review and approval of the designer selection procedures for certain public agencies, including Mass. Technology Collaborative; Mass. Convention Center Authority; Massport; Department of Housing and Community Development; Massachusetts School Building Authority.

The Board had a busy and productive year. We trust our involvement in expediting the selection of designers will be beneficial to the Commonwealth in providing the necessary supplementary support needed for DCAMM's expanded workload.

The Board looks forward to continued cooperation and assistance in achieving the Commonwealth's goal of providing well designed public buildings at reasonable cost. Our efforts were eminently supported by the DSB office staff. The staff has endeavored to provide a timely and effective response to the needs of the Board and have at all times given the highest priority to expediting the processing of new requests for designer selection.

In compliance with the General Laws and past practices, this Report will be distributed to the State House library and various architectural and engineering organizations and will be made available to the public upon request. This document constitutes the Designer Selection Board's Forty-Eighth Annual Report.

#### **EXECUTIVE NARRATIVE**

The Board acted on twenty-four (24) projects in this calendar year. There are two (2) additional 2017 projects to be scheduled in 2018.

The procedures employed to select finalists for each project were in accordance with Chapter 7C of the Massachusetts General Laws, and were tailored to maintaining the goals of the Board, namely to:

- (a) ensure that the commonwealth receives the highest quality design services for all its building projects;
- (b) provide for increased confidence in the procedures followed in the procurement of design and design related services;
- (c) promote consistency in the methods of procurement of design and design related services;
- (d) foster effective broad-based participation in public work within the design professions; and
- (e) provide safeguards for the maintenance of the integrity of the system for the procurement of designers' services within the commonwealth.

#### DISTRIBUTION OF DESIGNER SELECTION ACTIVITY

During the 2018 calendar year, there was no one major area of concentration in the designer selection workload; rather, there was a variation of types of projects. (See Recommendations and Appointments tab)

#### **OTHER SIGNIFICANT ISSUES**

#### I EXEMPTION FROM THE JURISDICTION OF THE DESIGNER SELECTION BOARD

In accordance with Chapter 7C, Section 46 of the General Laws, this Board is authorized to approve Designer Selection Procedures for certain public agencies i.e. the Mass. Convention Center Authority; Mass. Technology Collaborative; Massachusetts Port Authority; Department of Housing and Community Development; Massachusetts School Building Authority. Upon approval of such procedures, the respective agency is empowered to perform its own designer selections for two years. If they do not meet with the Board's approval, (specified in writing) they are prohibited from selecting any Designer firms until they have the Boards approval.

During 2018 the Board reviewed Designer Selection Procedures for the following public agencies, with the dispositions shown:

#### A. Massachusetts Port Authority (Massport)

On June 13, 2018, the Board voted to grant a two-year exemption to Massport expiring on June 22, 2020.

#### B. Massachusetts Convention Center (MCCA)

On July 25, 2018, the Board voted to grant a two-year exemption to MCCA expiring on July 9, 2020.

# A. Request of Extended Services for Roofing Replacement at the Bristol County House of Correction: SMRT

On January 10, 2018, the Board reviewed the above request from DCAMM and voted to re-advertise this project for a roof replacement at the Bristol County House of Correction.

On January 10, 2018, the Board reviewed the above request from DCAMM and voted not to approve this request to extend the services for Studio G Architects, Inc. for the above project.

#### III <u>LEGAL MATTERS</u>

#### A. Interpretations of Chapter Seven M.G.L.

From time to time, the Board receives inquiries, by telephone, by mail and by email, asking for our interpretations of the laws governing designer selection procedures. The questions may come from city or town officials, members of designer selection bodies, or practicing architects and engineers.

The Executive Director and his staff attempt to research the applicable laws, and particularly to find reasonably similar cases in the Board's files.

Up until a few years ago, the Bureau of Labor and Industries was available for answering such questions, but that practice has ceased. As a replacement, the Office of the Attorney General, Fair Labor & Business Practices has assumed an interpreter's role.

The Office of General Counsel of the DCAMM is a tireless source of help with legal questions on the designer selection laws, and although they have a heavy workload, they attempt to always give a timely response.

Another valuable source of information in these matters has been the Inspector General's Office.

#### **IV MISCELLANEOUS**

#### A. **BOARD MEMBERSHIP**

In accordance with the intent of the enabling legislation, the Designer Selection Board is a constantly self-renewing body.

During this year, the Executive Director and his assistant has been in constant touch with the Director of Appointments to the Office of the Governor in order to replace certain members of the DSB.

Many thanks to the selfless volunteers of the DSB who donate many hours of their time and expertise in service to the Commonwealth.

#### **B. BOARD ACTIVITIES**

• Discussion: DCAMM House Doctor/Small Projects – January 24, 2018

Jack Keleher and Liz Minnis from DCAMM met with the Board to update the Small Project House Doctor contracts. DCAMM will submit quarterly reports and report back to the Board in a year.

Discussion: DSB Application form update and iPADS – April 18, 2018

Bill Perkins met with 13 members of the design community and 2 members from MSBA to get feedback on the DSB Application form. He will have the 1<sup>st</sup> draft ready for review by the board members at the next meeting. Jessica Tsymbal suggested we do a beta test and select 6 firms (small, medium, large) to fill out the application form approved by the Board. Firms will use the new form by resubmitting on old projects that they previously applied for (house doctor and study/design); then they will be asked to provide feedback on the form. Rebecca Sherer requested a report for projects that have been selected by the DSB. She would like the report to show the status of projects, monies paid, types of projects and in geographical locations. Bill said that he would contact DCAMM for this information. Roberto Melendez handed out the iPADS to the members.

• Discussion: DSB Guidelines – May 6, 2018

Bill Perkins submitted draft guidelines to the Board for review. The Board will notify Bill of any changes by the next meeting.

• Discussion: DCAMM Presentation – July 25, 2018

Liz Minnis and Jay Mitchell discussed the capital funding for current and future projects.

- Discussion: The following items were discussed by the Board September 5, 2018
  - 1. Formverse The Board wants to allow pictures in Section 8a and 8b. Formverse does not have this capability as of yet. Mr. Perkins will update the Board in 2 months.
  - 2. Guidelines Mr. Perkins will resend Guidelines to the Board and will discuss at a future meeting.
  - 3. Error and Omissions The Board requested Carol Gladstone, DCAMM Commissioner and Liz Minnis, DCAMM Deputy Commissioner of Planning to attend a future meeting for discussion on this item.
  - 4. Design Team The Board will discuss at a future meeting
  - 5. Video Policy The Board will discuss at a future meeting
- Discussion: Guidelines September 19, 2018

The Board reviewed the guidelines and after a brief discussion Beth McDougal volunteered to make the necessary changes to reduce the size, eliminate repetition and add any other information deemed appropriate. It will be discussed at the next DSB meeting on October 10, 2018.

• Discussion: DCAMM – Policy related to Application Errors and Omissions – October 10, 2018

Liz Minnis, DCAMM Deputy Commissioner of Planning and Ryan Moore, DCAMM Legal were present to discuss the policy of the Board relating to application errors and omissions. There was a discussion regarding firms being notified of errors and omissions in their project application before the Board reviews the applications at the regular DSB meetings. Ken Wexler motioned to keep the existing DSB policy. This motion was seconded by Gregory Brown. Mitch Keamy opposed.

The existing DSB policy is as follows:

DSB Staff will inform the Board of any missing information or incomplete applications. The Board will review thee applications at regular DSB meetings and will then take a vote as whether to leave them in for consideration or to disqualify them. The applicants will not be notified of any error or omissions until after the DSB meeting.

• Discussion: DCAMM – Policy related to Licensed Disciplines in MA– October 10, 2018

There was a discussion with the Board regarding consultants to be registered/licensed in Massachusetts. Jessica Tysmbal made a motion that the Board make a statement to enforce the statutes of the State of Massachusetts that all relevant professions which have licenses for any given project must be registered in Massachusetts and request that DCAMM modify the language in the advertisements to reflect that statutes of the Commonwealth of Massachusetts. This motion was seconded by Gregory Brown. Motion was approved unanimously.

DCAMM will remove the asterisks in the section of the advertisement listing the Application Evaluation – Personnel and modify the language to reflect the statutes of the Commonwealth of Massachusetts.

#### • Discussion: Video Policy - October 10, 2018

Francis Harrigan made a motion below, seconded by Gregory Brown. Motion was approved unanimously to the following:

- 1. All visitors must sign an agreement allowing them to be recorded during the DSB meetings
- 2. The Board will be notified when visitors are logged into the meeting
- 3. Members and staff must sign an agreement allowing them to be recorded during the DSB meetings
- 4. Do not live stream project interviews
- 5. All meetings must be recorded while live streaming
- 6. Online viewers agreement to not record DSB meetings
