# MA-RPO DATA RELEASE NOTES

These release notes are meant to assist end users in their interpretation and utilization of the 2019 MA-RPO dataset. This document augments, rather than supersedes, the 2015 Data Release Notes, the 2017 Data Release Notes and the 2018 Data Release Notes. Unless otherwise stated in this document, the items described in the 2015, 2017, and 2018 Data Release notes are also applicable to the 2019 data files and have not been reproduced here. ### Data Year

The MA-RPO Program requires that filings be accurate as of a specific date to enhance uniformity and comparability across filings. The dates for each file in the 2019 filing are listed below.

## **Abbreviated Applications**

Provider Organizations that were approved to file abbreviated applications did not submit a physician roster as part of their filings. These applicants establish contracts on behalf of a group of physicians that also participate in a larger physician network. For example, a multi-specialty physician practice may establish some fee-for-service contracts independently while also participating in an Independent Physician Association (IPA) for its risk contracts. If the multi-specialty physician practice attested that all of its physicians would be reported on the IPA's physician roster, the MA-RPO Program approved the multi-specialty practice to file an abbreviated application. To identify a Provider Organization whose physician roster includes an abbreviated applicant's physicians, refer to data element RPO-39: Legal Name of Third-Party Contracting Entity(ies) in the abbreviated applicant's Background Information file, or refer to the list below.

Please note that Encompass Health Corporation and Quest Diagnostics Incorporated do not establish any contracts on behalf of physicians, and therefore, while not qualifying for abbreviated applications, have not submitted physician rosters.

# 2019 Updates to the List of Registering Provider Organizations

Two organizations that registered in 2018 underwent organizational changes that affected their registration for 2019.

<u>Foundation of the Massachusetts Eye and Ear Infirmary, Inc.</u>: Partners HealthCare System, Inc. acquired Foundation of the Massachusetts Eye and Ear Infirmary in 2018. In its 2019 filing, Partners reported the applicable Foundation of the Massachusetts Eye and Ear Infirmary information as required by the Data Submission Manual.

<u>Reliant Medical Group, Inc.</u>: UnitedHealth Group, Inc. acquired Reliant Medical Group, Inc. in 2018. In its 2019 filing, UnitedHealth Group reported the application Reliant Medical Group information as required by the Data Submission Manual.

### **New Reporting Requirements**

The MA-RPO Program added some new reporting requirements in 2019, as described below.

<u>Payer Mix File</u>: The Payer Mix file is designed to collect total Gross Patient Service Revenue by payer category during the most recent fiscal year. Provider Organizations were required to complete a Payer Mix file for each of their owned physician practices. Full reporting specifications for the Payer Mix file can be found on pages 82 - 84 of the <u>2019 Data Submission Manual</u>.

Facilities File New Data Elements: Four new data elements were added to the Facilities File.

- RPO-87A: Inpatient Beds (Hospital Satellites), which asks Hospital Satellites if they have staffed inpatient beds
- RPO-87B: Emergency Services, which asks Hospitals, Clinics, and their Satellites whether the Facility has an emergency department or is considered a Satellite Emergency Facility
- RPO-87C: Adult Trauma Center Level, which asks Facilities that responded "Yes" in RPO-87B to indicate their Adult Trauma Center Level
- RPO-87D: Pediatric Traume Center Level, which asks Facilities that responded "Yes" in RPO-87B to indicate their Pediatric Trauma Center Level

<u>Financial Statements</u>: In August 2018, CHIA updated their financial reporting requirements to collect annual and quarterly financial reports from systems and corporately affiliated physician practices. As part of the 2019 filing, the MA-RPO Program did not require separate financial statement templates for systems or physician practices that had submitted comparable information to CHIA.
