

# Massachusetts Low Emission Vehicle Program

## 2019 Zero Emission Vehicle Credits

### Manufacturer Volume Status

The Zero Emission Vehicle (ZEV) Regulation requires large and intermediate volume vehicle manufacturers to deliver and place in service within Massachusetts (MA) a certain percent of ZEVs (such as battery electric and fuel cell vehicles), and plug-in hybrids. The table below lists the 2019 vehicle manufacturers subject to the ZEV requirements.

### Manufacturer Sales in Massachusetts

A vehicle manufacturer's 2019 ZEV requirement is based on a percentage of all passenger cars and light-duty trucks (LDTs) from 0 to 8,500 pounds, delivered for sale in MA. The table below is the 2019 MA vehicle production of large volume and intermediate volume manufacturers.

## Manufacturer Credit Balances

TZEV = Transitional Zero Emission Vehicle (plug-in hybrids)
