### Section E: In-Person Early Voting for the September 2020 State Primary

# St. 2020, c. 115: AN ACT RELATIVE TO VOTING OPTIONS IN RESPONSE TO COVID-19.

Section 7 (b)(1) states that the election officers and registrars of every city or town shall allow any qualified voter to cast an early ballot in person for the September primary election during the early voting period, which shall begin on Saturday, August 22, 2020 and end on Friday, August 28, 2020. Early voting in person shall also apply to any city or town election held at the same time.

Section 7 (d)(1) states that each city and town shall establish an early voting site for the primary election that shall include the election office for the city or town; provided, however, that if the city or town determines that the office is unavailable or unsuitable for early voting in the primary election, the registrars of each city or town shall identify and provide for an alternative centrally-located, suitable and convenient public building within that city or town as an early voting site.
