# 2021 CHARLES E. SHANNON COMMUNITY SAFETY INITIATIVE BROCKTON

Funded by the Executive Office of Public Safety and Security's Office of Grants and Research, the Charles E. Shannon Community Safety Initiative (Shannon) is modeled after the Office of Juvenile Justice and Delinquency Prevention's Comprehensive Gang Model. Shannon is a multi-sector approach used to address a community's gang and youth violence problem. Each community receiving Shannon funding demonstrates the presence of risk factors for youth and gang violence. Shannon participants must be between the ages of 10-24 years.

#### Youth Risk Assessments

## 69% Youth in danger of engaging in risky LOW-RISK\* behavior or gang activity.

16% Youth exposed to the same risk factors MODERATE- as low-risk youth, as well as additional risk factors such as truancy.

15% Youth who are perpetrators or victims of HIGH-RISK\* shooting or stabbing violence, and/or are known gang members.

#### Success Highlight

"Participant N was 17, involved in a gang that she felt she could not leave, and experiencing homelessness. She had recently been a victim of street violence and expressed wanting to work with an outreach worker to get back on track and access shelter. Her case manager immediately connected her to a mental health clinician and established a safety plan with her while also providing basic needs supports. Participant N followed her safety goals, has left the crew/gang and located safe housing. She stated: 'I never felt like anyone cared about what would happen to me before' and 'You guys just showed up when I needed some help'"


### Gang Activity in Brockton

15 Street Gangs

200 Active Gang Members In 2021, it is estimated that fewer than 15 gangs drive the vast majority of criminal activity in Brockton. There are an estimated 200 active members with 67.5% between ages 10-24. Social media is an effective and ubiquitous recruitment tool. Additional recruitment involves requesting favors of youth like getting food, acting as a lookout, and renting cars or hotel rooms. This draws youth into the ranks while insulating gang members by creating barriers to their identities.

Gangs in Brockton continue to engage in firearms violence, including three shooting murders in a span of three weeks in August through September. Motor vehicle theft is a common delinquent activity for gang members, especially youth trying to prove their worth. Truancy is also pervasive, as is fighting at school. That has been an especially serious problem during fall and winter of 2021.
