

MassDEP GHG Reporting Program Summary Report and Facility List

Emissions Year 2020

(Publication Date: February 14, 2022)

This document includes 2020 greenhouse gas emissions data reported by facilities to the Massachusetts Department of Environmental Protection (MassDEP) pursuant to 310 CMR 7.71 and the Global Warming Solutions Act. The document includes two parts: Part 1 summarizes key information in charts and narrative form, and Part 2 lists all facilities that reported greenhouse gas emissions pursuant to 310 CMR 7.71.

After 2015, MassDEP transitioned GHG reporting by facilities to an internal online reporting platform, eDEP, which is designed to facilitate emissions reporting by facilities by combining greenhouse gas reporting with the other air pollutants reported under Source Registration. Technical limitations of eDEP necessitated some changes in the universe of reported emissions sources, so a direct comparison between emissions prior to 2016 may not show every change at the facility level. Additionally, due to technical challenges during the first reporting years, 2016-2017, MassDEP is not publishing a summary report for those years.

All quantities included in this report are expressed in carbon dioxide equivalent metric tons. Carbon dioxide equivalent (CO₂e) means that for gases other than carbon dioxide, the number of tons of emissions is adjusted to account for each gas's individual intensity as a greenhouse gas, known as the global warming potential (GWP). With the transition to eDEP, the GWPs were also updated from those previously used in CRIS, accounting for some additional differences between the emissions reported under each platform. For example, in CRIS the GWP used for methane was 21; in eDEP, that number has been updated to 25 given the most recent data from the Intergovernmental Panel on Climate Change (IPCC). If a source were to emit 100 metric tons of methane, this report would show 2,500 tons under the methane (CH₄) column heading. A similar change in GWP occurred for nitrous oxide, as well, in this case decreasing to 298 in eDEP from 310 in CRIS.

For emissions year 2019, 288 facilities reported 12,705,767 metric tons of carbon dioxide-equivalent greenhouse gas emissions. When considering the information below, it is important to understand that only emissions from large stationary facilities are reported to the MA GHG Registry. For example, emissions from residential and commercial space and water heating are not reported unless they are located at a large facility that reports greenhouse gas emissions to the MA GHG Registry.

The Largest Emitters: The twenty-five largest emitters emitted 74.8% of the total reported quantity of carbon dioxide-equivalent emissions, and the top 10 accounted for 52.6% of the total quantity of carbon dioxide-equivalent emissions reported to the registry. The twenty-five largest emitters include thirteen electric power plants, six waste-to-energy facilities, three local distribution companies (LDCs), two landfills, and one university. For most of these facilities the majority of emissions came from combusting fossil fuels. The notable exceptions were five waste-to-energy facilities, for which 55.1% emissions were from biogenic carbon sources, and four LDCs for which 94.8% of emissions were from methane.

Fossil Carbon Dioxide (CO₂): Two-hundred and seventy-five (275) facilities reported a total of 9,320,300 metric tons of carbon dioxide emissions from combustion, or 73.4% of the total emissions reported to the registry. The top ten emitters, consisting of nine fossil fuel electric power generation facilities and one waste-to-energy facility accounted for 58.9% of the emissions from combustion of fossil fuels. (A small quantity of other process emissions of non-biogenic carbon dioxide is included in this category.¹)

Biogenic Carbon Dioxide (CO₂): Forty-two (42) facilities reported a total of 2,093,230 metric tons of carbon dioxide emissions from combustion of biogenic material, or 16.5% of the total emissions reported to the registry. Ten facilities, including 6 waste-to-energy facilities, two landfills, one manufacturer, and biomass combustion facility, accounted for 87.17% of the emissions from combustion of biogenic material. (Biogenic carbon dioxide emissions include emissions from combustion of biomass, biofuels, municipal solid waste, and landfill gas, and any carbon dioxide emitted as a component of landfill gas.)

Methane (CH₄): Two-hundred and eighty-six (286) facilities reported a total of 1,166,856 metric carbon dioxide-equivalent tons of methane, or 9.2% of the total emissions reported to the registry. Ten facilities, including six LDCs, three landfills, and one waste-to-energy facility, accounted for 89.8% of the methane emissions.

Nitrous Oxide (N₂O): Two-hundred and seventy-one (271) facilities reported a total of 58,083 metric tons carbon dioxide-equivalent of nitrous oxide, or 0.5% of the total emissions reported to the registry. Ten facilities, including six waste-to-energy facilities, one biomass electric generation facility, one manufacturer, one hospital, and one wastewater treatment plant accounted for 82.5% of the total nitrous oxide emissions.

Sulfur Hexafluoride (SF₆): Eight (8) facilities reported a total of 11,329 metric tons carbon dioxide-equivalent of sulfur hexafluoride, or 0.1% of the total emissions reported to the registry. The facilities where four manufacturers, three fossil fuel electric power generation facilities, and one research and development laboratory.


¹ Process emissions are the byproduct of a specific industrial process rather than from the fuel combustion required to conduct that process. For example, a manufacturer that produces cement burns fuel to run the process (these are stationary combustion emissions). The cement itself also releases CO₂ during the process because heated limestone breaks down into calcium oxide and CO₂ (these are process emissions).

Hydrofluorocarbons and Perfluorocarbons (HFCs and PFCs): Seven (7) facilities reported a total of 55,969 metric tons carbon dioxide-equivalent of hydrofluorocarbons and perfluorocarbons, or 0.4% of the total emissions reported to the registry. The facilities were facilities such as manufacturers, hospitals, and research and development facilities (Hydrofluorocarbons and perfluorocarbons are used as refrigerants, and by electronics manufacturers. Each gas in this category has a different global warming potential.)



Figure 1: Percent of Reported Emissions by Gas Type





The sectors in Figure 3 are categorized by Institutions, Manufacturing, Natural Gas and Petroleum Infrastructure, Power Generation, Waste Management, and Other. Institutions include hospitals, universities, hotels, correctional facilities, and national security institutions. Manufacturing includes material manufacturing, pharmecuetical preparation, and paper and fabric finishing mills. Natural Gas and Petroleum Infrastructure includes transmission and distribution of natural gas, and oil terminals. Power Generation facilities include fossil, biomass, and landfill gas-powered EGUs. Waste Management facilities include landfills, sewage treatment, and waste-to-energy facilities. Other includes transportation systems and steam and air conditioning suppliers.
