The U.S. Department of Health and Human Services has contracted with Biobot to collect wastewater data on the Covid-19 variants at no cost to utilities. Biobot is still taking applicants, though they are filling quickly. I would recommend that any interested utilities email BioBot ASAP. Twice-weekly sampling for this phase 2 Biobot contract will begin on June 7th and last for 9 weeks. Approximately 320 utilities will be included, representing 100 million people. Data collected through this effort will be shared with participating utilities and will also be available in HHS Protect and on the CDC DCIPHER platform.
