

# 2021 CHARLES E. SHANNON COMMUNITY SAFETY INITIATIVE FITCHBURG/GARDNER

Funded Partners: City of Fitchburg Police Department, City of Gardner Police Department, Making Opportunity Count, Mount Wachusett Community College, Shining Light Ministries Inc., Spanish American Center

Funded by the Executive Office of Public Safety and Security's Office of Grants and Research, the Charles E. Shannon Community Safety Initiative (Shannon) is modeled after the Office of Juvenile Justice and Delinquency Prevention's Comprehensive Gang Model. Shannon is a multi-sector approach used to address a community's gang and youth violence problem. Each community receiving Shannon funding demonstrates the presence of risk factors for youth and gang violence. Shannon participants must be between the ages of 10-24 years.

## Youth Risk Assessments

78%  
LOW-RISK\* Youth in danger of engaging in risky behavior or gang activity.

16%  
MODERATE-RISK\* Youth exposed to the same risk factors as low-risk youth, as well as additional risk factors such as truancy.

6%  
HIGH-RISK\* Youth who are perpetrators or victims of shooting or stabbing violence, and/or are known gang members.

\* % of youth assessed for risk; responses in risk assessment may have been impacted by changes in context due to COVID-19 pandemic.


## Gang Activity in Fitchburg/Gardner

Historically, gangs have centered on hot-spot areas with recruitment taking place in schools and high-crime neighborhoods, placing truant and unemployed youth at a higher risk. Recently, gangs have been tied to drug trafficking/sales, underscoring the need to continue to partner with schools, actively engage truant students and their families, provide additional support services to hot spot areas, offer youth employment opportunities, and reduce drug abuse in the region.

## 5-Year Crime Trends for Young People Ages 10-24, 2017-2021



### Changes in Crime for Young People Ages 10-24, 2017-2021

- Simple assaults in...
  - Massachusetts decreased 25%
  - Fitchburg/Gardner decreased 37%
- Robberies in...
  - Massachusetts decreased 47%
  - Fitchburg/Gardner decreased 0%
- Aggravated assaults in...
  - Massachusetts decreased 20%
  - Fitchburg/Gardner decreased 61%
