4. Discussion for Adopting Remote Meeting Procedures

The temporary law permitting full remote participation will expire July 15, 2022. Lynn Read, Counsel for the Bureau, explained that the Legislature is considering another extension or permanent change in the law, but if any gap in the extension occurs, the Board would need to use the Attorney General's remote open meeting procedures, which must be adopted in advance. Members discussed the advantages and disadvantages of meeting remotely and expressed a desire to continue to do so if the pending legislation is passed. MOTION to adopt the Attorney General's remote open meeting procedures in 940 CMR 29.10, to be used if the temporary law is not extended by July 15, 2022, made by Sharon Orr,

seconded by Allan Berry; motion passed by unanimous roll call vote. (Dan Dumont, Scott King, Justin Fishlin, Allan Berry, Pauline Lally, Sharon Orr, and John Viola)

A MOTION to cancel the July 20, 2022 meeting was made by Dan Dumont and seconded by Jason Fishlin; motion passed by unanimous roll call vote. (Dan Dumont, Scott King, Justin Fishlin, Allan Berry, Pauline Lally, Sharon Orr, and John Viola)

5. Jurisdictional Report by the Office of Public Safety and Inspections

Daniel Kilburn presented the OPSI jurisdictional report to the Bureau members.
