2022 Zero Emission Vehicle Credits

Manufacturer Volume Status

The Zero Emission Vehicle (ZEV) Regulation requires large and intermediate volume vehicle manufacturers to deliver and place in service within Massachusetts (MA) a certain percent of ZEVs (such as battery electric and fuel cell vehicles), and plug-in hybrids. The table below lists the 2022 vehicle manufacturers subject to the ZEV requirements.

Manufacturer Sales in Massachusetts

A vehicle manufacturer's 2022 ZEV requirement is based on a percentage of all passenger cars and light-duty trucks (LDTs) from 0 to 8,500 pounds, delivered for sale in MA. The table below is the 2022 MA vehicle production of large volume and intermediate volume manufacturers.

Manufacturer Credit Balances
