EVENING POST PUBLISHING PROVIDES NOTICE OF DATA EVENT

July 8, 2024

Evening Post Publishing ("Evening Post") recently discovered a data security event that may impact the confidentiality and security of information related to certain individuals. As we continue to work toward notifying potentially impacted individuals directly, we are providing information about the event, our response, and steps potentially impacted individuals can take to better protect against the possibility of identity theft and fraud, should they feel it is appropriate to do so.

On March 20, 2024, Evening Post became aware of suspicious activity on our network. We immediately took steps to secure our environment and initiated an investigation into the nature and scope of the activity with the assistance of third-party forensic specialists. The investigation determined that our network was subject to unauthorized access between March 13 and March 20, 2024, and that certain files were acquired by an unknown actor while on the network. In response, Evening Post is undertaking a thorough review of the data determined to be at risk to assess the type of information at issue and to whom that information relates.

Evening Post determined that some of the affected files contained sensitive information related to individuals. The type of information varies per individual but may include some or all of the following: name, Social Security number, date of birth, passport number, financial account information, credit card information, and driver's license number.

The confidentiality, privacy, and security of information in our care is among our highest priorities. Upon discovering the incident, we immediately commenced an investigation to confirm its nature and scope. We also reported the event to law enforcement, and implemented additional safeguards related to data privacy and security.

On July 8, 2024, Evening Post began mailing notification letters to individuals whose information may have been affected by the event and for whom it has a postal address.
