Re: Notice of Data Security Incident

Dear Sample:

Central Securities Corporation (“Central Securities”) is a closed-end investment management company traded on the NYSE American stock exchange. We are writing to inform you that we experienced a cybersecurity incident that involved some of your personal information.

In the normal course of business, we are provided with access to the personal information of stockholders and other related parties. Additionally, as per regulatory obligations, we are at times required to collect personal information from our directors, stockholders, and other related parties. This notice explains the incident, steps we have taken in response, and additional information on steps you may take to help protect your information.

***What Happened***

On Monday, May 20, 2024, we discovered unauthorized activity in our internal systems. We immediately began an investigation and engaged leading third-party cybersecurity and forensic experts to respond to the issue and assist us in remediating it. We also notified law enforcement and are cooperating with their investigation.

Our investigation determined that an unauthorized third party gained access to Central Securities’ internal systems on or about April 17, 2024, seemingly through a legitimate account of one of our vendors that had authorized access to our systems. The unauthorized third party then used our vendor’s access to remove certain data from our systems around May 20, 2024. A thorough review of that data was conducted to identify what information was involved and identify individuals to whom the data related.

***What Information Was Involved***

The data review determined that the data involved contained some of your personal information, including your name and one or more of the following: Social Security number, stockholder account number, and address.

***What We Are Doing***

We have terminated the relevant vendor’s access to our systems and are currently evaluating the security of all third-party access to our systems. We have also implemented additional security protocols designed to further enhance the security of our network, internal systems, data, and applications. Central Securities will continue to evaluate additional steps that may be taken to further increase our defenses. We are continuing to support federal law enforcement’s investigation.

**Free Credit Report.** We remind you to be vigilant for incidents of fraud or identity theft by reviewing your account statements and free credit reports for any unauthorized activity. If you identify any unauthorized charges on your financial account statements, you should immediately report any such charges to your financial institution. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting companies. **For Colorado, Georgia, Maine, Maryland, Massachusetts, New Jersey, and Puerto Rico residents:**

You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

**Security Freeze.** Security freezes, also known as credit freezes, restrict access to your credit file, making it harder for identity thieves to open new accounts in your name. You can freeze and unfreeze your credit file for free. You also can get a free freeze for your children who are under 16. And if you are someone's guardian, conservator or have a valid power of attorney, you can get a free freeze for that person, too.

How will these freezes work? Contact all three of the nationwide credit reporting agencies – Equifax, Experian, and TransUnion. If you request a freeze online or by phone, the agency must place the freeze within one business day. If you request a lift of the freeze, the agency must lift it within one hour. If you make your request by mail, the agency must place or lift the freeze within three business days after it gets your request. You also can lift the freeze temporarily without a fee.

The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement.

It is essential that each copy be legible, display your name and current mailing address, and the date of issue.

**For New Mexico residents:** You may obtain a security freeze on your credit report to protect your privacy and ensure that credit is not granted in your name without your knowledge. You may submit a declaration of removal to remove information placed in your credit report as a result of being a victim of identity theft. You have a right to place a security freeze on your credit report or submit a declaration of removal pursuant to the Fair Credit Reporting and Identity Security Act. **Fraud Alerts.** A fraud alert tells businesses that check your credit that they should check with you before opening a new account. An initial fraud alert stays on your credit report for one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft with the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. To place a fraud alert on your credit reports, contact one of the nationwide credit bureaus. A fraud alert is free. The credit bureau you contact must tell the other two, and all three will place an alert with their versions of your report.

**Federal Trade Commission and State Attorneys General Offices.** If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or avoid identity theft. **Reporting of identity theft and obtaining a police report.**

You have the right to obtain any police report filed in the United States in regard to this incident. If you are the victim of fraud or identity theft, you also have the right to file a police report.

**For Iowa residents:** You are advised to report any suspected identity theft to law enforcement or to the Iowa Attorney General.

**For Massachusetts residents:** You have the right to obtain a police report if you are a victim of identity theft. You also have a right to file a police report and obtain a copy of it.

**For Oregon residents:** You are advised to report any suspected identity theft to law enforcement, the Federal Trade Commission, and the Oregon Attorney General.

**For Rhode Island residents:** You have the right to file or obtain a police report regarding this incident. One Rhode Island resident was impacted by this incident.
