Dear Sample A. Sample:

WinStar Farm LLC ("WinStar Farm") writes to notify you of an event that may involve some of your personal information. We are providing you with notice of the event, steps we have taken in response, and resources available to help you better protect your information, should you feel it is appropriate to do so.

What Happened? On July 15, 2024, WinStar Farm became aware of a cyber security incident in which an unauthorized third party gained access to certain systems in our network and encrypted certain files. Upon becoming aware of this incident, WinStar Farm initiated an investigation into the nature and scope of the incident as well as worked to restore any impacted systems. The investigation determined that unauthorized access to certain WinStar Farm systems occurred, and that certain information on our systems may have been viewed or taken without authorization on July 15, 2024. On or around September 13, 2024, we determined that some of the information involved may include personal information. In an abundance of caution, we are notifying individuals whose personal information may have been involved in this event.

What Information Was Involved? The information that may have been viewed or taken includes your name and Social Security number. We have no evidence that identity theft or fraud has occurred as a result of this event.

What We Are Doing? We take this event and the security of personal information in our care seriously. Upon discovering the network disruption, we took steps to secure the network, investigate the activity, and determine the scope of impacted information. Our immediate response to this event also included prompt notification to local and federal law enforcement authorities.

As an added precaution, we are providing you with [twelve (12)/ twenty-four (24)] months of complimentary access to credit monitoring and identity restoration services through Experian, as well as guidance on how to better protect your information. Although we are covering the cost of these services, due to privacy restrictions, you will need to complete the activation process yourself using the enrollment instructions included within the enclosure to this letter.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements and monitoring your free credit reports for suspicious activity and to detect errors. Further, please review the enclosed "Steps You Can Take to Protect Your Personal Information" section of this letter for additional information. We also encourage you to enroll in the complimentary credit monitoring services we are offering you.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer's name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth;
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.
