Notice of Data Security << Incident/Breach>>

CRC Insurance Services, LLC ("CRC") is writing to tell you about a security incident that may have exposed some of your personal information that we have in our possession because of our role as a wholesale insurance distributor placing insurance at the request and on behalf of retail insurance agency clients with a variety of insurance carriers. We take the protection and proper use of your information very seriously. For this reason, we are contacting you directly to explain the circumstances of the incident.

What Happened.

On February 19, 2025, CRC learned of potential unauthorized access to data on its computer systems. CRC immediately responded with support from a third-party cyber forensic expert to investigate, contain and remediate the incident. CRC also notified law enforcement. Based on CRC's review, on February 3, 2025, data was accessed and acquired without authorization from a file server used by employees in one of its local offices.

What Information Was Involved.

We are sending you this notice because the information contained in the data may have included your name, as well as your << PI Categories>>.

What We Are Doing.

As part of its response, CRC took steps to determine the nature and scope of the incident and engaged a leading forensic and data review firm. CRC has also implemented a range of measures to further enhance its cyber preparedness and minimize the risk of a recurrence, including enabling additional technical measures and providing updated guidance to employees.

Additionally, CRC has secured the services of Kroll to provide optional identity monitoring at no cost to you for <<ServiceTerminMonths>> months. Kroll is a global leader in risk mitigation and response, and its team has extensive experience helping people who may have sustained an unintentional exposure of confidential data. Identity monitoring services are available fee-free to you and include Credit Monitoring, Fraud Consultation, and Identity Theft Restoration.

Free Credit Report. It is recommended that you remain vigilant by reviewing account statements and monitoring your credit report for unauthorized activity, especially activity that may indicate fraud and identity theft. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting agencies.

For Colorado, Georgia, Maine, Maryland, Massachusetts, New Jersey, Puerto Rico, and Vermont residents: You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

Fraud Alerts. There are two types of fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for at least one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft and you have the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. You can place a fraud alert on your credit report by contacting any of the three national credit reporting agencies.

Security Freeze. You have the ability to place a security freeze, also known as a credit freeze, on your credit report free of charge.

A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you may use an online process, an automated telephone line, or submit a written request to any of the three credit reporting agencies listed above. The following information must be included when requesting a security freeze (note that, if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past 5 years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, and display your name, current mailing address, and the date of issue.

Federal Trade Commission and State Attorneys General Offices. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or minimize the risks of identity theft.

For Oregon residents: You are advised to report any suspected identity theft to law enforcement, the Federal Trade Commission, and the Oregon Attorney General.
